**Description:** This course is an introduction to the political institutions and processes of the United States and Nevada. Successful completion of this course satisfies UNLV's U.S. and Nevada Constitution requirements. During the course, we will examine political, economic and social issues as they relate to political institutions and processes.

**Prerequisites:** There are no prerequisites for Political Science 101.

**Attendance:** Roll will not be taken. However, students will be responsible for all material, including that presented in class. Some questions on each test will be derived only from lecture material. Therefore, regular class attendance is strongly advised.

You may not attend class if you are not registered for the class. You may not attend a course section if you are not registered for that section. If you are requested by the Registrar or an Advisement office to obtain a faculty signature for any kind of add/drop or other administrative action, you will be referred to the Chairman of the Political Science Department.

November 2 is the final day you may drop or withdraw from a class without refund.

### **Assignments and Grading:**

#### Exams

There will be three closed-book exams of multiple choice, true-false and short answer essay questions. You will need to bring a Scantron form, a pencil and an exam book (or blank sheets of paper) to each exam. The results of each exam will comprise one-third of your grade.

Students will be graded on knowledge and understanding of textbook reading assignments and class lectures. Reading assignments and exam dates are set forth in the schedule below. Please note that the amount of material covered during the semester is subject to slight change at the discretion of the instructor, taking into account time constraints and the extent of coverage of various topics. Students will be informed in advance of the specific material to be covered on exams. The exams are not cumulative.

Material from the readings not included in the lectures and material from the textbooks not included in the lectures may be the basis for exam questions. Electronic dictionaries are not permitted to be used during exams.

This syllabus, an outline of the textbooks and class lectures, and a study guide before each exam will be provided under this course on Web Campus.

Your Scantron form and essay paper, with scores, will be returned to you following Exams I and II. Scores for Exams I, II and III also will be posted on WebCT.

### Make-up Exams and Early/Late Exams

Religious Holidays: If you miss an examination because of a religious holiday that you observe, you will have the opportunity to make up the examination shortly thereafter. You must notify the instructor by August 31, the last day of late registration, if you anticipate missing an examination because of observance of a religious holiday so that alternative arrangements can be made.

Official extracurricular activity: If the date of any of the examinations conflicts with your participation in an official extracurricular activity, you will have the opportunity to make up the examination shortly thereafter. You must provide official written notification no less than one week prior to the examination so that alternative arrangements can be made.

Extraordinary circumstances: If extraordinary circumstances require you to miss an exam you will have the opportunity to make up the exam on the last day of scheduled class only, December 5.

There will be no make-up exam for the third exam, which will be given only on December 12, during exam week.

Early exams will not be given.

### Class Discussion of Current Events

Discussions of current events related to U.S. and Nevada government and political activities will enhance your understanding of material covered in the text and the lectures. You should become familiar with current political trends and events through regular reading of newspapers and/or internet news sites, and through watching or listening to television and radio news and discussions shows. Current events material of relevance to class content may be posted on WebCt in advance of class to promote class discussion.
