### **IV. Approval of Minutes**

President Michael Gordon called for a motion to approve the February minutes. Caleb Picker (Psychology) motioned to approve and Christopher Conner (Sociology) seconded. Gordon asked for any corrections or additions and hearing none, he called for a vote, which was unanimous to approve.

### **V. Speakers**

- Juanita Fain, Vice President of Student Affairs – Dr. Fain explained as Vice President of Student Affairs her duties revolve around campus life, admissions, financial aid, administration, wellness, and police services. GPSA has worked for the last two years with Student Affairs to bring dental chairs to campus. Fain suggested that Student Affairs has a subscription for the New York Times, and if GPSA combines our sponsorship of NY Times together with theirs, maybe we can bring a speaker on campus. Student Affairs is compliant with EEO, as well as ADA. Fain has also committed \$6k to GPSA which would be half of the NAGPS lifetime membership fee.
- Jamie Davidson, Associate Vice President of Student Wellness – Dr. Davidson said the goal of the mandatory wavier program is to maintain affordable insurance on campus for students. Health insurance prices nationwide are rising. Only two insurance companies were willing to put a bid in because we do not have mandatory health insurance and because our Medical Loss Ratio (MLR) is so high. UNLV’s MLR is at 99%, and not profitable for insurance companies to carry the university. UNLV would like our rate to be closer to 80% and insurance companies would like MLRs of 60%. After sending out offers to 14 companies, UNLV got 2 offers back. (Wells Fargo is UNLV’s insurance broker). The mandatory health insurance would most likely target full time students and not part time students. But there needs to be lots more discussion on this issue. All insurance plans have to cover everything for up to half a million dollars. Insurance providers are saying they will not continue to quote UNLV. It will be much cheaper to get student insurance than other insurance. If the mandatory health insurance is not passed, UNLV will not be able to carry insurance for students. Davidson believes the mandatory health insurance will be significantly cheaper than Silver State Insurance. Aetna will consider offering

insurance just for graduate students on the mandatory waiver plan, but that plan will be higher than if the hard waiver is required for undergrads as well. The regents will be voting soon, and Davidson would like to get support for this resolution from graduate students.

- Kate Hausbeck Korgan, Senior Associate Dean, Graduate College – Dr. Korgan noted that the Graduate College is very supportive of the mandatory health insurance with a hard waiver. This is because if the hard waiver is not mandated, UNLV will not be able to offer health insurance for students. This will negatively affect graduate recruitment and retention because providing health insurance for students is a normative thing. If UNLV doesn't have an affordable plan for international students, they will have to purchase a more expensive option. The Graduate College will do their best to keep the insurance waiver rates as is for GAs. Again, think about students that really need this plan; without the mandatory health insurance--these students will not have an insurance option at UNLV. The Graduate College has recently started retention funding awards that could help students maxed out on financial aid, so this could help that issue in a small way.

## **VI. Budget Report**

Treasurer Reed reported the March monthly expenditures. She directed the council's attention to the top of the report, the March student wages are listed at \$4054.00 for the staffing in the Graduate Student Commons. She continued with the operating expenses for the month of March: noting the monthly postage and telephone costs, \$791.30 for the travel expenses for the 3 e-board members (Jennifer, Michael and Sharon) trip to Carson City for the Feb. 25th Nevada Education Awareness Day and printing expenses at \$654.89 for the Research Forum. She further noted the hosting expenses for March. \$350.00 was spent for the February social held at the Freakin' Frog.

\$728.52 was brought from the sales in the Graduate Student Commons; as well as \$2,986.09 from the remaining spring semester student fees. Bring the year-to-date revenue in at \$261,609.03.

The balance forward is \$157,840.87 with a balance of \$169,979.57

President Gordon asked for a motion to approve the budget Caleb Picker (Psychology) motioned to approve the budget report; Christopher Conner (Sociology) seconded. After a call for the vote, Council unanimously approved the budget report as presented.

- Board of Regents – Legislatively, Michael Gordon testified last week on the funding formula. This Wednesday they're hearing about conceal carry weapons on campus.

She asked the publications committee to stay behind after the meeting to set up the next publications committee meeting. **XI. Public Comment** – There was open discussion of the pros and cons of the mandatory hard waiver. If nothing is done, our rates will rise 20%-30%. If we go to the hard waiver program the prices may go up a little or possibly down. Some argued, once the individual mandate hits, everyone will have to buy health insurance. Therefore it's better to pass this mandatory health insurance waiver now and get cheaper rates. Others felt the student health rates given are inflated. Some discussed how the Council voted down this same proposal at the February meeting and believed we should maintain our previous vote in this matter.

Dr. Fred Krauss, Director of Graduate Outreach, said he was not aware of a university that does not offer health insurance to students. He said a mandatory health insurance waiver does not look nearly as bad as not being able to offer insurance to students at UNLV.
