

Restricted Licensees Regulatory Compliance

This comprehensive program is designed for owners, operators, and managers of restricted license locations and addresses what a restricted licensee can expect from the routine compliance procedures performed by the Nevada Gaming Control Board. The seminar addresses some of the more common violations and how to prevent them. It will include a discussion of operational requirements related to progressive jackpots, supervision of the slot machines, minimum bankroll requirements, internal controls, record keeping requirements, problem gambling, and various other regulations. It will also address the live entertainment tax and applicable state gaming fees and taxes, as well as reviewing the rules relating to promotional slot machines and promotional activity.
