Question 1:

Regarding your solicitation below, is there a reason why the group could not have their overnight in Flagstaff? That is where we usually start our trips. We do the orientation at the hotel the night prior to the launch date and then bus the passengers up to Lees Ferry. If we arrange transportation from Vegas to Flagstaff, is that acceptable to you? If so, we would bid on your solicitation.

Question 2:

7-Day Motorized Grand Canyon Expedition on July 23-29, 2015. To charter this trip, you will need a total of 16 passengers. The group discount is one free space. If this is your first time doing a rafting trip through the Grand Canyon with your group, you might consider this one boat trip only. The two boat trip is for 29 passengers and that might be too much to coordinate for

first timer. Let me know ahead of time if you are interested on this date and I will continue to do the bid you request.

Question 3:

I finished Section E part 1 and 2 then Section F and G are asking about Nevada Business License #. I'm sorry but Hatch River Expedition office and warehouse is located in Arizona. Can you tell me if I'm reading this wrong? Most of the concessionaires in the Grand Canyon are located in Arizona (whom I'm sure you emailed as well). Was this a waste of my time? Please explain.

Answer: If you are not required by the State of Nevada to obtain a business license, state on the form not applicable. For your convenience the following is an excerpt from the Nevada revised statutes.

NRS 80.015 Activities not constituting doing business.

- 1. For the purposes of this chapter, the following activities do not constitute doing business in this State:
 - (a) Maintaining, defending or settling any proceeding;
 - (b) Holding meetings of the board of directors or stockholders or carrying on other activities concerning internal corporate affairs;
 - (c) Maintaining accounts in banks or credit unions;
 - (d) Maintaining offices or agencies for the transfer, exchange and registration of the corporation's own securities or maintaining trustees or depositaries with respect to those securities;
 - (e) Making sales through independent contractors;
 - (f) Soliciting or receiving orders outside of this State through or in response to letters, circulars, catalogs or other forms of advertising, accepting those orders outside of this State and filling them by shipping goods into this State;
 - (g) Creating or acquiring indebtedness, mortgages and security interests in real or personal property;
 - (h) Securing or collecting debts or enforcing mortgages and security interests in property securing the debts;
 - (i) Owning, without more, real or personal property;
 - (j) Isolated transactions completed within 30 days and not a part of a series of similar transactions;

- (k) The production of motion pictures as defined in NRS 231.020;
- (I) Transacting business as an out-of-state depository institution pursuant to the provisions of title 55 of NRS; and
- (m) Transacting business in interstate commerce.
- 2. The list of activities in subsection 1 is not exhaustive
- 3. A person who is not doing business in this State within the meaning of this section need not qualify or comply with any provision of this chapter, <u>chapter 645A</u>, <u>645B</u> or <u>645E</u> of NRS or title 55 or 56 of NRS unless the person:
 - (a) Maintains an office in this State for the transaction of business;
 - (b) Solicits or accepts deposits in the State, except pursuant to the provisions of <u>chapter</u> 666 or 666A of NRS;
 - (c) Solicits business for the activities of a mortgage broker as defined by NRS 645B.0127 or the activities of a mortgage banker as defined by NRS 645E.100; or
 - (d) Arranges a mortgage loan secured by real property which is not commercial property as defined by NRS 645E.040.
- 4. The fact that a person is not doing business in this State within the meaning of this section:
 - (a) Does not affect the determination of whether any court, administrative agency or regulatory body in this State may exercise personal jurisdiction over the person in any civil action, criminal action, administrative proceeding or regulatory proceeding; and
