As immigration expanded into new destination states such as Nevada and Utah, challenges related to immigration face the communities in these states. Between 1990 and 2000, Nevada's immigrant population increased by over 200 percent. In 2004-05, with the Boyd School of Law, I received an interdisciplinary planning initiative award which examined and proposed solutions to some of Nevada's growth in its immigrant subpopulation using the lenses of Economics, Social Welfare, Law and Education. Aside from various departments on campus, we involved community agencies in the planning process.
