Course Description

An introduction to radiology including the various modalities, ethics, professional associations, radiation protection, equipment, and quality assurance. In addition, there will be study of medical terminology within the various body systems.

Course Objectives

Upon completion of this course, the student will be able to:

1. Define and apply medical terminology prefix and suffixes
2. Build medical terms using connecting vowels and root words
3. Define the medical terminology of various body systems.
4. Explain the various modalities within Radiology to include Sonography, Computed Tomography, Magnetic Resonance Imaging, Nuclear Medicine, Radiation Therapy, and Interventional Radiology.
5. Properly explain how to apply radiation protection measures.
6. Define ethics and relate it to medical imaging
7. Identify the various professional opportunities in Radiology

Video Lectures

The video lectures will be posted at 8am on the day of your scheduled class. There will be quiz questions that are embedded in the video lectures. You will not be graded on those quizzes in the video lecture, however the quiz questions will be similar to the questions you will see on your scheduled graded quiz. **Use the quiz questions in the video lectures as your study guide for the quizzes, midterm and final exam.**

Note: You must take the quizzes in the video lectures, otherwise you will not be able to finish watching the video. Remember, you must watch the video lectures in their entirety.

Quizzes

There are 10 scheduled quizzes for this class. You will be able to take the quiz on the scheduled day from 8 am - 11 pm. There will be no make-up quizzes, however I will turn your lowest quiz score from the semester and change it into a 100 (this applies to only one quiz). Your quizzes will be similar to the questions in the quizzes in each of the video lectures. Each quiz will have 10 questions that will be multiple choice and/or true/false questions.

Discussions

There will be a discussion question each week that will be asked in a video lecture. You are to write your response in the discussions box in Panopto for that video. If you do not answer the

discussion question in Panopto, points will be deducted from your overall grade. Discussions in Panopto are 15% of your grade.

Midterm

The midterm will be 50 questions. They will be multiple choice and/or true false questions. The questions will be similar to the questions from your graded quizzes.

Final Exam

The final exam will be 50 questions. They will be multiple choice and/or true false questions. The questions will be similar to the questions from your graded quizzes.

Auditing a Course

Auditing a course allows a student to continue attending the lectures and/or laboratories and discussion sessions associated with the course, but the student will not earn a grade for any component of the course. Students who audit a course receive the same educational experience as students taking the course for a grade, but will be excused from exams, assessments, and other evaluative measures that serve the primary purpose of assigning a grade.

Classroom Conduct

Students have a responsibility to conduct themselves in class and in the libraries in ways that do not interfere with the rights of other students to learn, or of instructors to teach. Use of devices

such as cellular phones and pagers, or other potentially disruptive activities are only permitted with the prior explicit consent of the instructor. Students are specifically prohibited to record classes without instructor authorization, including online/remote classes (either audio only, or video and audio). The instructor may rescind permission at any time during the class. If a student does not comply with established requirements or obstructs the functioning of the class, the instructor may initiate an administrative withdrawal of the student from the course.

Since the COVID-19 pandemic forced some instruction to be delivered remotely starting in Spring 2020, numerous students have asked instructors to record their synchronous classes, so that they can access them at their convenience. Instructors who agree to record their classes (audio only, or video and audio) should inform students in advance. Recorded lectures may not be broadly released to anyone, but made available exclusively to those students enrolled in the class during the particular academic term. Recorded lectures must be stored securely, and are subject to the Nevada System of Higher Education's Records Retention Policy, meaning that the recordings can only be deleted 120 days after the end of class (i.e., after grades are posted). Once this requirement is met, the recordings should be deleted. Class recordings are protected from disclosure, as they are deemed part of an educational record under the Family Educational Rights and Privacy Act (FERPA).

Identity Verification in Online Courses

All UNLV students must use their Campus-issued ACE ID and password to log in to WebCampus-Canvas.

Incomplete Grades

The grade of “I” (Incomplete) may be granted when a student has satisfactorily completed three-fourths of course work for that semester/session, but cannot complete the last part of the course for reason(s) beyond the student’s control and acceptable to the instructor, and the instructor believes that the student can finish the course without repeating it. For undergraduate courses, the incomplete work must be made up before the end of the following regular semester. Graduate students receiving “I” grades in 500-, 600-, or 700-level courses have up to one calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the period indicated, a grade of “F” will be recorded, and the student’s GPA will be adjusted accordingly. Students who are fulfilling an Incomplete grade do not register for the course, but make individual arrangements with the instructor who assigned the “I” grade.

Missed Classwork

Any student missing class, quizzes, examinations, or any other class or laboratory work because of observance of religious holidays will be given an opportunity during that semester to make up the missed work. When disagreements regarding this policy arise, decisions can be appealed to the Department Chair/School Director, College/School Dean, and/or the Faculty Senate Academic Standards Committee.
