Course Description:

Fluid dynamics is a difficult subject requiring familiarity with mathematical relations and engineering principles. Exact solutions to the equations of motion that describe fluid flow do not exist except for idealized conditions. In this graduate level course, the governing equations will be developed and then reduced to more tractable forms for solution. Approximate solutions to practical problems of engineering interest will also be examined. Both analytical and numerical techniques will be utilized. Your final grade will be based on the quality of your performance. The course will consist of:

Midterm (35%)

Final (45%)

Project/Homework (20%)

Course Learning Outcomes:

By the end of this course, students will be able to:

1. Find exact solutions to Fluid Mechanics governing equations of motion for idealized conditions.
2. Derive reduced forms of the governing equations that are tractable for solution.
3. Find approximate solutions to practical problems of engineering interest.
4. Understand and apply analytical techniques to solve governing equations.
5. Understand and apply numerical techniques to solve governing equations.

Incomplete Grades—The grade of I—Incomplete—can be granted when a student has satisfactorily completed three-fourths of course work for that semester/session but for reason(s) beyond the student's control, and acceptable to the instructor, cannot complete the last part of the course, and the instructor believes that the student can finish the course without repeating it. The incomplete work must be made up before the end of the following regular semester for undergraduate courses. Graduate students receiving "I" grades in 500-, 600-, or 700-level courses have up to one calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the time indicated, a grade of F will be recorded and the GPA will be adjusted accordingly.
