5. COURSE OBJECTIVE AND OUTCOMES

This course will provide the theory and practical application for treatment planningendosseous implants in dentistry.

At the conclusion of this course, the student will be able to:

- 1. Discuss the indications, risks, benefits, alternatives, and prognosis of implanttherapy for replacing single or multiple teeth and when referral is warranted.
- 2. Develop a restoratively-driven treatment plan for replacing single or multiple units with dental implants.
- 3. Demonstrate the procedure for making impressions for implant restorations.
- 4. Classify and identify the components used in the restoration with dental implants.
- 5. Evaluate the immediate and delayed restorative and surgical complications related to dental implant therapy.
- 6. Discuss the long-term outcomes maintenance of dental implants.
