**Course Description:** Introduction to numerical mathematics and scientific computing. Topics including methods of error estimation, interpolation theory, numerical integration, and solutions of linear and non-linear equations. Emphasizes hands-on computer work based on these techniques.

**Grading Policy:** Your grade will be determined by weighting the following components:

A. Assignments 30%.

B. Two tests at 20% each.

C. Final examination at 30%.

**Assignments:** To be posted on the UNLV WebCampus. Late assignments will not be accepted.

**Tests:** Two tests have been scheduled on Tuesdays, September 28 and November 2, 2021. The make-up tests will be given only if you have a legitimate written excuse. Otherwise, the weight for your final examination will be 30% plus the weights for your missing tests.

**Final Examination:** The comprehensive final examination has been scheduled on Tuesday, December 7, 2021. No make-up final examination will be given under any circumstances.

(ii) Octave – a high-level language, primarily intended for numerical computations. It is a free software that runs on Linux, macOS, and Windows. The Octave syntax is largely compatible with Matlab. Please visit its website for more information: <https://www.gnu.org/software/octave/>.

**Learning Outcomes:** On successful completion of this course, students should be able to:

1. Construct and analyze various numerical methods for
  - Solving nonlinear equations (Chapter 2).
  - Approximating functions by polynomials (Chapter 3).
  - Numerical differentiation and integration (Chapter 4).
  - Solving systems of linear equations (Chapter 6).
  - Solving systems of nonlinear equations (Chapter 10).
2. Apply the appropriate numerical methods to compute the approximate solutions with the desired accuracy to the specified problems.
3. Implement numerical methods by using Octave or other programming languages.
4. Write efficient and well-documented programs and present numerical results in an informative way.

**Incomplete Grades:** The grade of "I" (Incomplete) may be granted when a student has satisfactorily completed three-fourths of course work for that semester/session, but cannot complete the last part of the course for reason(s) beyond the student's control and acceptable to the instructor, and the instructor believes that the student can finish the course without repeating it. For undergraduate courses, the incomplete work must be made up before the end of the following regular semester. Graduate students receiving "I" grades in 500-, 600-, or 700-level courses have up to one calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the period indicated, a grade of "F" will be recorded, and the student's GPA will be adjusted accordingly. Students who are fulfilling an Incomplete grade do not register for the course, but make individual arrangements with the instructor who assigned the "I" grade.
