## **Course Description:**

The course of Real Analysis is the gateway to graduate work in pure and applied mathematics. The course Real Analysis I is designed to cover Measure Theory, Integration Theory, Differentiation and Integration, Hilbert Spaces, and Banach Spaces.

**Learning Outcomes:** By the end of the course, students will be able to

- understand the idea and construction of Lebesgue Measure in  $\mathbb{R}^N$  and apply the basic concepts of measurable sets and functions;
- learn and apply the basic results of Lebesgue integration theory and its ramifications in particular Fubini's theorem;
- learn and apply the concept of differentiation, related theorems, and general results on differentiation of functions and integrals in the context of measure theory;
- become familiar with Hilbert spaces and Banach spaces, in particular  $L_p$  spaces and related results.

## **Incomplete Grades**

The grade of “I” (Incomplete) may be granted when a student has satisfactorily completed three-fourths of course work for that semester/session, but cannot complete the last part of the course for reason(s) beyond the student’s control and acceptable to the instructor, and the instructor believes that the student can finish the course without repeating it. For undergraduate courses, the incomplete work must be made up before the end of the following regular semester. Graduate students receiving “I” grades in 500-, 600-, or 700-level courses have up to one calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the period indicated, a grade of “F” will be recorded, and the student’s GPA will be adjusted accordingly. Students who are fulfilling an Incomplete grade do not register for the course, but make individual arrangements with the instructor who assigned the “I” grade.

## **Missed Classwork**

Any student missing class, quizzes, examinations, or any other class or laboratory work because of observance of religious holidays will be given an opportunity during that semester to make up the missed work. This policy will not apply in the event that completing the assignment or administering the examination at an alternate time would impose an undue hardship on the instructor or the University that could be reasonably avoided. There should be a good faith effort by both the instructor and the student to agree to a reasonable resolution. When disagreements regarding this policy arise, decisions can be appealed to the Department Chair/School Director, College/School Dean, and/or the Faculty Senate Academic Standards Committee.

For purposes of definition, extracurricular activities may include, but are not limited to: academic recruitment activities, competitive intercollegiate athletics, fine arts activities, liberal arts competitions, science and engineering competitions, and any other event or activity sanctioned by a College/School Dean, and/or by the Executive Vice President and Provost.
