

**Syllabus for
MUS 319
Multimedia for the Performing Arts**

Prerequisite:

MUS 231, MUS 239 or equivalent Pro Tools experience

Recommended:

MUS 232, MUS 133A, MUS 233A

Course Description:

This course is intended to be a 3 credit Lab and Lecture exploring the various formats of media that are available to the performing artist today. Students involved in dance, music, theater and film will learn to create a portfolio of their work using state-of-the-art technology.

This in-depth look at analog and digital media will include hands-on access to these formats and the equipment that is utilized in its reproduction.

Objective:

Master the techniques of recording, storage, handling, and archiving on to modern media. Media types will include such diverse formats as HTML, DVD-A and Hard Disk, Streaming of AudioNideo, and will demonstrate how to transfer data between them. Students will be expected to develop projects that will be their "electronic business card."

Learning Outcomes

1. **Demonstrate the ability to operate digital audio workstations and digital consoles used in the audio field for music, theatre, dance, film, video, and multi-media productions.**
2. **Produce several examples of both studio and on-location recordings, the ability to conceive, organize, setup, and finalize projects for various media formats and multi-track setups.**
3. **Demonstrate the ability to design and organize live sound reproduction events including consoles, speakers, amplifiers, microphones, signal processing, cabling, and acoustic treatments.**

Basis for Grade:

1. **Participation in class and Lab 20%**
2. **Completion of projects 40%**
 - A. **Record a Full-length concert using MPEG technology & sync audio from a separate source.**
 - B. **Create a digital portfolio DVD that included audio, video, text & visuals**
3. **Mid-Term and Final Exams (Final Exam will have both a written and Lab examination) 40%**

Auditing Classes

Identity Verification in Online Courses

All UNLV students must use their Campus-issued ACE ID and password to log in to WebCampus-Canvas.

UNLV students enrolled in online or hybrid courses are expected to read and adhere to the [Student Academic Misconduct Policy](https://www.unlv.edu/studentconduct/misconduct/policy), <https://www.unlv.edu/studentconduct/misconduct/policy>, which states that “acting or attempting to act as a substitute for another, or using or attempting to use a substitute, in any academic evaluation or assignment” is a form of academic misconduct. Intentionally sharing ACE login credentials with another person may be considered an attempt to use a substitute, and could result in investigation and sanctions, as outlined in the Student Academic Misconduct Policy.

To the greatest extent possible, all graded assignments and assessments in UNLV online courses should be hosted in WebCampus-Canvas or another UNLV-managed platform that requires ACE login credentials for access.

Incomplete Grades

The grade of “I” (Incomplete) may be granted when a student has satisfactorily completed three-fourths of course work for that semester/session, but cannot complete the last part of the course for reason(s) beyond the student’s control and acceptable to the instructor, and the instructor believes that the student can finish the course without repeating it. For undergraduate courses, the incomplete work must be made up before the end of the following regular semester. Graduate students receiving “I” grades in 500-, 600-, or 700-level courses have up to one calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the period indicated, a grade of “F” will be recorded, and the student’s GPA will be adjusted accordingly. Students who are fulfilling an Incomplete grade do not register for the course, but make individual arrangements with the instructor who assigned the “I” grade.

Missed Classwork

Any student missing class, quizzes, examinations, or any other class or laboratory work because of observance of religious holidays will be given an opportunity during that semester to make up the missed work. The make-up opportunity will apply to the religious holiday absence only. It is the responsibility of the student to notify the instructor within the first 14 calendar days of the course for Fall and Spring courses (except for modular courses), or within the first 7 calendar days of the course for Summer and modular courses, of their intention to participate in religious holidays which do not fall on state holidays or periods of class recess. In accordance with the policy approved by the Faculty Senate regarding missed class time and assignments, students who represent UNLV in any official extracurricular activity will also have the opportunity to make up assignments, provided that the student provides official written notification to the instructor no less than one week prior to the missed class(es).

The spirit and intent of the policy for missed classwork is to offer fair and equitable assessment opportunities to all students, including those representing the University in extracurricular activities. Instructors should consider, for example, that in courses which offer a “Drop one” option for the lowest assignment, quiz, or exam, assigning the student a grade of zero for an excused absence for extracurricular activity is both contrary to the intent of the Faculty Senate’s policy, and an infringement on the student’s right to complete all work for the course.

This policy will not apply in the event that completing the assignment or administering the examination at an alternate time would impose an undue hardship on the instructor or the University that could be reasonably avoided. There should be a good faith effort by both the instructor and the student to agree to a reasonable resolution. When disagreements regarding this policy arise, decisions can be appealed to the Department Chair/School Director, College/School Dean, and/or the Faculty Senate Academic Standards Committee.

For purposes of definition, extracurricular activities may include, but are not limited to: academic recruitment activities, competitive intercollegiate athletics, fine arts activities, liberal arts competitions, science and engineering competitions, and any other event or activity sanctioned by a College/School Dean, and/or by the Executive Vice President and Provost.

Rebelmail

Rebelmail is UNLV's official email system for students and by University policy, instructors and staff should only send emails to students' Rebelmail accounts. Rebelmail is one of the primary ways in which students receive official University communications, information about deadlines, major Campus events, and announcements. All UNLV students receive a Rebelmail account after they have been admitted to the University. Emailing within WebCampus-Canvas is also acceptable.
