## AMENDMENT NO. 2 TO CONTRACT 6461 FOR RETAIL LEASE AGREEMENT (STUDENT UNION)

THIS AMENDMENT NO. 2 ("**Amendment**") TO CONTRACT 6461 dated May 1, 2014 ("**Agreement**"), is made effective as of July 25, 2022 (the "**Effective Date**") by and between U.S. Bank National Association, a national banking association ("**Bank**"), and Board of Regents of the Nevada System of Higher Education ("**NSHE**"), on behalf of the University of Nevada, Las Vegas ("**UNLV**" or "**University**").

### WITNESSETH:

WHEREAS, the Board of Regents repealed the emergency COVID policy at NSHE Handbook, Title 2, Chapter 12, and the parties desire to amend "Section X. Immunizations";

NOW, THEREFORE, UNLV and Bank agree as follows:

- 1) **Amendment to Section 7.0, Use of Premises, Deleting Subsection 7.2, Immunizations**

Subsection 7.2, Immunizations is hereby deleted in its entirety.

- 2) **Counterparts.** This Amendment may be executed in two or more identical counterparts and delivered by facsimile or by .pdf or other comparable electronic format, with the same force and effect as if all required signatures were contained in a single, original instrument.
- 3) **Ratification.** All other terms and conditions of the Agreement shall remain the same.

**SIXTH AMENDMENT TO THE CONTRACT FOR  
CAMPUS ID CARD AND BANKING SERVICES  
FOR THE UNIVERSITY OF NEVADA, LAS  
VEGAS**

**Contract No. 6462**

This Sixth Amendment to the Contract for Campus ID Card and Banking Services for the University of Nevada, Las Vegas (this "Amendment") is effective as of July 25, 2022 ("Effective Date"), by and between the Board of Regents of the Nevada System of Higher Education, on behalf of the University of Nevada, Las Vegas ("University" or "UNLV") and U.S. Bank National Association ("Bank" or "Contractor").

**Recitals**

A.e Pursuant to the Contract for Campus ID Card and Banking Services entered into on May 1, 2014, and as amended July 29, 2015, April 26, 2016, December 12, 2018, September 27, 2019, and May 1, 2022 between University and Bank (collectively the "Contract"), Bank agreed to be the exclusive provider of Banking Services to the University that may be accessed by and through an ID Card.e

B.e The Board of Regents repealed the emergency COVID policy at NSHE Handbook, Title 2, Chapter 12. As a result, the parties desire to amend "Section X. Immunizations"

Accordingly, the parties agree as follows:


1.e **Article VI. Miscellaneous Provisions, "Section X. Immunizations"**

The above referenced Section X. Immunizations is hereby deleted in its entirety.e
