

## RE 334: REAL ESTATE INVESTMENT

### Course Description:

This course examines the process and techniques of analyzing real property as an investment medium as well as the effects of market conditions and government policies upon real estate investment.

### Prerequisite:

Admission to a business major/junior standing, and FIN 301.

### Required Textbook:

*Real Estate Finance and Investments, Fifteenth Edition*, William B. Brueggeman and Jeffrey D. Fisher, McGraw-Hill Irwin, New York, 2016.

### Learning Objectives:

- 1) Understand the nature of real estate markets and how value is determined.
- 2) Understand and utilize the underlying theory in the analysis of income producing real estate as an investment medium.
- 3) Apply time-value-of-money techniques in the calculation of before and after-tax cash flows.
- 4) Calculation the net present value and internal rate of return and traditional measures of investment analysis of a real estate investment.

**Incomplete Grades**—The grade of I—Incomplete—can be granted when a student has satisfactorily completed three-fourths of course work for that semester/session but for reason(s) beyond the student’s control, and acceptable to the instructor, cannot complete the last part of the course, and the instructor believes that the student can finish the course without repeating it. The incomplete work must be made up before the end of the following regular semester for undergraduate courses.
