Full Course Title: Cyber Law - Digital Intellectual Property & Privacy

Course Duration: 1 semester

Course Introduction: Cyber Law is the continuation of the Graduate Cyber Security Certificate; the prerequisite to this course is Introduction to Hacking. Students will have a general knowledge of cyber technology and cyber security. It is essential to have a solid foundation of cyber technology principles in order to comprehend how technology is reducing or affecting the power of traditional regulatory tools. Students will clarify issues of jurisdiction and sovereignty of the internet and be introduced to the basic principles of digital intellectual property, online privacy, and the basic elements of software copyright.

Objectives:

- ❖ Identify cyber laws and regulatory tools
- ❖ Understand the role of government and jurisdiction in technology
- ❖ Reflect on U.S laws regarding the internet and IP
- ❖ Judge case studies and court outcomes regarding online privacy and cyber security
- ❖ Classify cyber privacy, copyright, and software IP

Incomplete Grades—The grade of I—Incomplete—can be granted when a student has satisfactorily completed three-fourths of course work for that semester/session but for reason(s) beyond the student's control, and acceptable to the instructor, cannot complete the last part of the course, and the instructor believes that the student can finish the course without repeating it. The incomplete work must be made up before the end of the following regular semester for undergraduate courses. Graduate students receiving "I" grades in 500-, 600-, or 700-level courses have up to one calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the time indicated, a grade of F will be recorded and the GPA will be adjusted accordingly. Students who are fulfilling an Incomplete do not register for the course but make individual arrangements with the instructor who assigned the I grade.
