## FIN 301 - Principles of Managerial Finance

**Required Text:** Keown/Martin - Foundations of Finance, 9/e

**Objective:** This is an introductory class concentrating on the theory and practice of

corporate finance. The use of finance theory to solve practical problems will be highlighted and where appropriate shortcomings in theory and

practice will be discussed.

**Homework:** Assigned chapter readings and homework problems are expected to be

completed <u>prior</u> to covering the corresponding chapter in class.

**Keys to Success:** 1. Attend class.

2. Read assigned Chapters prior to lecture.

3. Attempt <u>Homework</u> problems prior to us going over these problems in class.

4. Try to <u>Understand</u> the logic of finance instead of attempting to memorize.

## **Learning Outcomes:**

- 1. To be able to demonstrate an understanding of the time value of money and its applications.
- 2. To be able to demonstrate an understanding of the methods and process of capital budgeting.
- 3. To be able to demonstrate an understanding of the basics of capital structure decisions and dividend policies.
- 4. To be able to demonstrate an understanding of the basics of the relationship between risk and return.
