LEARNING OUTCOMES:

Analytical and written studies covering advanced jazz harmony as it relates to specific style developments in jazz history. Application of these principles will be emphasized with each student composing and arranging pieces to demonstrate understanding of the concepts discussed.

Students will:

- transcribe and analyze improvised solos of jazz masters and describe their relevance to the development of jazz theory and composition.
- research a survey of jazz theory, composition and arranging materials and compile resources for jazz instruction in this material for potential teaching opportunities at the university level. Techniques of jazz arranging will be addressed in terms of the direct and practical usage of jazz harmony and composition and each
- compose one big band arrangement utilizing many of these concepts.
- summarize in a class presentation on all topics.

At the end of the semester, students will have obtained the skills described above and will gain the ability to apply them in musical and pedagogical situations consistent with university and professional expectations.

Incomplete Grades—The grade of I—Incomplete—can be granted when a student has satisfactorily completed three-fourths of course work for that semester/session but for reason(s) beyond the student's control, and acceptable to the instructor, cannot complete the last part of the course, and the instructor believes that the student can finish the course without repeating it. The incomplete work must be made up before the end of the following regular semester for undergraduate courses. Graduate students receiving "I" grades in 500-, 600-, or 700-level courses have up to one calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the time indicated, a grade of F will be recorded and the GPA will be adjusted accordingly. Students who are fulfilling an Incomplete do not register for the course but make individual arrangements with the instructor who assigned the I grade.
