## Master of Music Recital – MUS 698

Course Syllabus

The Master of Music (MM) Recital in your applied instrument is a culminating experience for your graduate academic study in music. The **objectives** of the course are to present a memorized and diverse program of a minimum of 40 minutes of music, to organically collaborate with other musicians when required, and to write effective program notes.

## **Learning outcomes** of the course, the successful student will:

- perform at a superior technical level with/on their instrument,
- -demonstrate an informed stylistic understanding of a diversity of classical or jazz repertoire,
- -comprehend the form, scope and grammar of successful program notes and/or poetic texts and translations, and
- plan, organize and execute future recitals expected of a musician entering the profession.

Required Texts: Original copies of music to be presented on the recital.

Timeline: There will be a pre-recital hearing approximately 3-4 weeks prior to your scheduled

recital date to assess readiness for the recital.

Grading: Your recital will be graded by committee on the quality of the following

components: Repertoire, intonation, tone quality, technique, diction/articulation,

presentation, level of preparation, artistry, interpretation, and musicality.

## Procedures:

- 1. The student must present the recital repertoire for faculty approval at the applied jury in the semester before the recital.
- 2. There is a \$50 fee attached to the course.
- 3. All students must enroll in graduate major level Applied Music in the semester in which the recital is scheduled.
- 4. The student must schedule a recital date with the School of Music Scheduler a minimum of three months in advance of the requested recital date, as dates fill quickly. Scheduling may begin as early as approximately mid-semester of the previous semester. The student will be emailed the Recital

- Scheduling & Approval Form, Stage Set-Up Form and Recital Packet. The Recital Packet also includes the Concert Program printing guidelines.
- 5. The student, in consultation with the Accompanying Coordinator and/or the applied instructor, selects the accompanist(s) and keeps a record of rehearsal, lesson and performance hours with the accompanist(s). The recitalist is responsible for all accompanist fees.
- 6. All completed forms, program, and posters are due three (3) weeks prior to the recital date to the Scheduler. All program content must be in Concert Program Format, and must be emailed to the Scheduler as a Microsoft Word document. Posters must be emailed PDF format, prior to printing. Failure to adhere to this deadline or to use the template may result in recital cancellation or unavailability of services.
- 7. The jury of faculty assigned to attend this recital will average their grades for the recital and record the grade in Web Grading.
- 8. A student who fails to complete the recital as scheduled will receive a failing grade and will forfeit the recital fee.

Incomplete Grades—The grade of I—Incomplete—can be granted when a student has satisfactorily completed three-fourths of course work for that semester/session but for reason(s) beyond the student's control, and acceptable to the instructor, cannot complete the last part of the course, and the instructor believes that the student can finish the course without repeating it. The incomplete work must be made up before the end of the following regular semester for undergraduate courses. Graduate students receiving "I" grades in 500-, 600-, or 700-level courses have up to one calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the time indicated, a grade of F will be recorded and the GPA will be adjusted accordingly. Students who are fulfilling an Incomplete do not register for the course but make individual arrangements with the instructor who assigned the I grade.
