

Dietetic Internship-Supervised Practice ONLY Estimated Program Costs

Students participating in the UNLV DI-Supervised Practice only will be responsible for the following costs (subject to change annually):

- Enrollment as a student for 6 credits of nutrition practice (NUTR 796, NUTR 797, NUTR 798).
- Tuition and fees for enrollment in NUTR 796, 797, and 798 is estimated to be \$2588.70 for Nevada residents and \$4712.70 for non-residents. Please go to the UNLV <u>tuition and fees</u> <u>page</u> for more information and updates.
- Fees for the DI are \$6,000 for 1,040 supervised practice hours.
- Total program fee, UNLV tuition and fees = approximately \$8,589 for Nevada residents and \$10,713 for non-residents.
- Health insurance is required. Students enrolling in 9 credits or more per semester or
 Graduate Assistants will be automatically billed for health insurance. Detailed information
 on UNLV student health plan options and costs can be found by clicking here. Spousal and
 family plans are available. Health insurance effective from 8/16/23 to 1/11/24 is \$1309.
 Health insurance effective 1/12/24 to 8/15/24 is \$1909.
- Criminal Background Check, Drug Screen, and Immunization Record Verification. Specific instructions are given to students admitted to the program. \$120.
- Select UNLV Risk Management courses. These courses are available to admitted interns through UNLV. There is no charge for these courses.
- A non-refundable \$60 internship application fee.
- Books: approximately \$200.
- Visual Veggies RDN Exam Subscription. Price varies depending on number of devices, method of installation, and additions (\$200-500).
- Supplies (calculator, general office supplies): approximately \$10.
- Personal room, board, and travel to practice sites.
- Liability insurance, available through Marsh Affinity Group Services, a service of Seabury and Smith, 1440 Renaissance Drive, Park Ridge, IL 60068-1400. Phone: (800) 503-9230. Click here for <u>website</u>. The cost is \$35-40 per year, depending on chosen coverage.
- Parking at UNLV: \$150 Annual, \$13.75 per month, \$9 per week, or \$4.50 per day. Metered parking or Pay by Phone (required app) in short increments also available. A free lot is available and a short walk to the BHS building. Students will only need parking for several days in the program and therefore daily permits are recommended.
- The average one-bedroom rental unit in Las Vegas is approximately \$1,280 per month. This cost varies significantly with size, location, and amenities offered with the property.

- Depending on the housing that the intern selects. All sites within the program are within comfortable driving distance.
- Student Membership in the Academy of Nutrition of Dietetics: \$58.
- Student Membership in the Nevada Academy of Nutrition of Dietetics: Cost Varies. Free if selected as part of your national membership.
- Membership in the UNLV Student Nutrition & Dietetic Association (SNDA): \$20.
- Students must apply to the UNLV Graduate College if they are accepted to the internship. The Graduate College application fee is \$60.
- Students must have a personal use computer with internet access and MS Office.

While our program costs are transparent, there could be slight changes to the tuition and program supplies due to COVID-19 or any other community health emergency. There could be medical costs associated with testing, vaccination, etc. Additional subscriptions or materials could be required if students are displaced from their site due to a community health emergency.

Financial Aid – DI Only

Most interns enrolled in UNLV DI-Supervised Practice only are not eligible for federal financial aid because completing this portion only does not result in a conferred degree. Students simultaneously enrolled in the MS Nutrition Sciences degree program (MS-DI or Clinical Nutrition & Dietetics Subplan) may be eligible. Most students are eligible for private student loans. We will certify to lending agencies that the intern is enrolled in six graduate credits and is enrolled in full-time supervised practice. MS Nutrition Sciences Degree Program (MS-DI/Clinical Nutrition & Dietetics Subplan)

Students participating in the UNLV DI will be responsible for the following costs (subject to change annually):

- Enrollment in 34 total credits, which includes 6 credits of supervised practice (NUTR 796, NUTR 797, NUTR 798).
- Tuition and fees for completing the 34 credits required for the program is estimated to be \$17,715 for Nevada residents and \$60,910 for non-residents. Please go to the UNLV <u>tuition and</u> <u>fees page</u> for more information and updates. NOTE: Students from out of state may take measures to establish <u>residency in Nevada</u>, saving significantly on tuition.
- Fees for the supervised practice portion of the program are an additional \$6,000 for 1,040 supervised practice hours.
- Total supervised practice program fee plus all needed UNLV tuition and fees = approximately \$23,715 for Nevada residents and \$66,910 for non-residents. NOTE: Students from out of state may take measures to establish <u>residency in Nevada</u>, saving significantly on tuition.
- Health insurance is required. Cost varies.
- Criminal Background Check, Drug Screen, and Immunization Record Verification. Specific instructions are given to students admitted to the program. \$120.

- Select UNLV Risk Management courses. These courses are available to admitted interns through UNLV. There is no charge for these courses.

Financial Aid - MS-DI

Students already holding a Master's degree and who enrolled in the supervised practice portion of the program only, may not be eligible for some forms of financial aid if they are not a degree-seeking student. Students enrolled in the MS Nutrition Sciences program, Clinical Nutrition & Dietetics subplan are eligible. Most students are eligible for private student loans. We will certify to lending agencies that the intern is enrolled in six graduate credits and is enrolled in full-time supervised practice. - An additional 28 credits are required to earn the M.S. Nutrition Sciences degree
- Nevada resident tuition & fees semester cost is approximately \$3,607.
- Non-resident tuition & fees semester cost is approximately \$12,085.
