Course Description

Introduction to techniques to evaluating alternatives in environmental and water resources systems. Topics include southwest U.S. water economic analysis, optimization using linear and dynamic programming, systems modeling using STELLA, analysis of droughts, and current research topics. Applications focus on surface water systems, operation, and reservoirs, water distribution and environmental systems.

Course Prerequisite(s):

CEE 413 or consent of instructor.

Course Rationale

Course introduces systems approach to modeling Environmental and Water Resources systems. The course uses lectures, readings, discussions, role playing game, hands-on model development, and use of simulation models to develop system thinking and system dynamics modeling skills. Special emphasis will be placed on case studies of successful applications of system dynamics. Students will learn to develop and test computer simulation models using Stella. The reading list consists of the selected chapters from course textbook (Stermann) and a variety of Journal Articles and case studies.

Course Goals

The main goals of this course are to:

1. develop an understanding of systems thinking approach and tools used for system dynamics modeling;
2. Learn about application of system dynamics from successful case studies and;
3. learn to use computer simulation tool Stella to develop robust model for policy analysis for water and environmental systems.

Learning Outcomes/Course Objectives

At the completion of this course, you will be able to:

- Describe the systems thinking and system dynamics modeling approach.
- Read, interpret, and develop causal loops diagrams
- Understand stocks and flows, and system structure
- Understand fundamental models of system behavior arising from interaction of reinforcing and balancing loops with time delays
- Develop, test and apply system dynamics models using Stella
- Evaluate and select policies to improve a water resources/environmental system using simulation modeling.

Evaluation Methods

You will be assessed in the course based on following five activities. The weightage of each activity is also provided:

1. Reading/in class and Homework: There is no textbook for this course; all reading material will be provided. You are expected to read the material prior to class and be prepared to discuss in class. The reading and homework are fundamental to learning the course subjects. The homework assignments will help you master the material. You will need to complete a short quiz at the beginning of class to demonstrate that you have read the material assigned. 20%
2. Midterm Exam: There will be a midterm exam that will test your understanding of the fundamental concepts learned in the first part of the course. 20%
3. Classroom Participation/attendance: You will be asked to be an active classroom participant. This includes being at class on time. Attendance will be taken at the beginning of class. 5%
4. Presentations: You will be required to make two presentations: i) Journal Article/book chapter/case study that will be assigned or selected from the reading list. ii) software use. First presentation will be an overview of the problem, method and major findings of assigned reading. Second presentation will focus on using different functions in the software. 15%

5. Design Projects: There will be a design projects due in the end of the semester. You will apply the concepts learned in the course to a real-life water resource or environmental system. Deliverables will include a project report and a video presentation. These projects are **VERY IMPORTANT** and are your final assessment in the course. More information is provided in design project guidelines document. Rubrics for both written report and video presentation will be provided. 40%

Attendance Policy

Your on time attendance in class is highly recommended. Some of the lectures and assignments will deal with material that is not in the text book. There will be regular in class exercises. Please inform me if you intend to miss a lecture for personal reasons or for a religious holiday so that an alternate arrangement can be made.

Auditing a Course

Auditing a course allows a student to continue attending the lectures and/or laboratories and discussion sessions associated with the course, but the student will not earn a grade for any component of the course. Students who audit a course receive the same educational experience as students taking the course for a grade, but will be excused from exams, assessments, and other evaluative measures that serve the primary purpose of assigning a grade.

Classroom Conduct

Students have a responsibility to conduct themselves in class and in the libraries in ways that do not interfere with the rights of other students to learn, or of instructors to teach. Since the COVID-19 pandemic forced some instruction to be delivered remotely starting in Spring 2020, numerous students have asked instructors to record their synchronous classes, so that they can access them at their convenience. Instructors who agree to record their classes (audio only, or video and audio) should inform students in advance. Recorded lectures may not be broadly released to anyone, but made available exclusively to those students enrolled in the class during the particular academic term. Recorded lectures must be stored securely, and are subject to the Nevada System of Higher Education's Records Retention Policy, meaning that the recordings can only be deleted 120 days after the end of class (i.e., after grades are posted). Once this requirement is met, the recordings should be deleted. Class recordings are protected from disclosure, as they are deemed part of an educational record under the Family Educational Rights and Privacy Act (FERPA).

Incomplete Grades

The grade of “I” (Incomplete) may be granted when a student has satisfactorily completed three-fourths of course work for that semester/session, but cannot complete the last part of the course for reason(s) beyond the student’s control and acceptable to the instructor, and the instructor believes that the student can finish the course without repeating it. For undergraduate courses, the incomplete work must be made up before the end of the following regular semester. Graduate students receiving “I” grades in 500-, 600-, or 700-level courses have up to one calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the period indicated, a grade of “F” will be recorded, and the student’s GPA will be adjusted accordingly. Students who are fulfilling an Incomplete grade do not register for the course, but make individual arrangements with the instructor who assigned the “I” grade.
