Course Description

Fundamentals of chemical equilibrium, chemical kinetics, reactor hydraulics, and advanced treatment processes. Applications to the design of advanced water and wastewater treatment facilities, including disinfection basins, advanced oxidation processes, activated carbon columns, and membranes.

CEE 650 or equivalent and Graduate Standing

Course Objectives

- 1. Calculate performance, retention time, and size of common types of reactors in water and wastewater treatment
- 2. Analyze and calculate efficiency and retention time for coagulation and flocculation processes
- 3. Analyze and calculate efficiency and bed depth for granular filtration process
- 4. Analyze and design adsorption process
- 5. Design chemical oxidation/advanced oxidation/photocatalysis processes
- 6. Design membrane processes
- 7. Analyze sludge characteristics and design sludge preliminary treatment and stabilization

- Overview of advanced water and wastewater treatment plants: overview of water treatment plant schemes, purpose of unit operations, overview of wastewater treatment plant schemes, classification of treatment processes (Handout and Chapter 1, 1-4 to 1-6)
- Chemical reaction engineering: part I, review of basic chemical kinetics, ideal reactors and their performances (batch, CSTR, and PFR); part II, non-ideal reactors, residence time distributions, tracer studies, predicting reactor performance (Handout, Chapter 1, 1-7 to 1-11)

- Coagulation and flocculation (chemical aspect): coagulants in water and wastewater treatment, mechanisms of destabilization by polymeric coagulants, mechanisms of destabilization by metal salt coagulants, role of dissolved natural organic matter in coagulation (Handout)
- Coagulation and flocculation (physical aspect): definitions, collision frequency function, perikinetic flocculation, orthokinetic (shear) flocculation, differential settling, and summary (Handout)
- Granular filtration: introduction and definitions, mechanisms of particle removal, transport model in filtration, role of particle size, dynamics of granular filtration (Handout)
- Adsorption: definitions, isotherms, activated carbon (properties and applications), kinetics, predictive models for packed beds, and ion exchange (Handout, Chapter 11, 11-9 and 11-11)
- Membrane processes: part I, introduction, classification, applications, reverse osmosis; part III, solute transport and separation mechanisms, membrane bioreactor; and part III, nanofiltration, ultrafiltration and microfiltration, fouling of pressure driven membrane (Handout, Chapter 11, 11-7)
- Chemical oxidation, advanced oxidation, and photocatalysis: applications, types of oxidants, processes, fundamentals/basic considerations, and limitations (Chapter 6, 6-7 to 6-9)
- Sludge processing and treatment: source, characteristics, regulations, preliminary treatment, thickening, anaerobic processes, and aerobic digestion (Chapter 15)

Auditing a course allows a student to continue attending the lectures and/or laboratories and discussion sessions associated with the course, but the student will not earn a grade for any component of the course. Classroom Conduct

Since the COVID-19 pandemic forced some instruction to be delivered remotely starting in Spring 2020, numerous students have asked instructors to record their synchronous classes, so that they can access them at their convenience. Recorded lectures may not be broadly released to anyone, but made available exclusively to those students enrolled in the class during the particular academic term. Recorded lectures must be stored securely, and are subject to the Nevada System of Higher Education's Records Retention Policy, meaning that the recordings can only be deleted 120 days after the end of class (i.e., after grades are posted). Once this requirement is met, the recordings should be deleted. Class recordings are protected from disclosure, as they are deemed part of an educational record under the Family Educational Rights and Privacy Act (FERPA).

For undergraduate courses, the incomplete work must be made up before the end of the following regular semester. Graduate students receiving "I" grades in 500-, 600-, or 700-level courses have up to one

calendar year to complete the work, at the discretion of the instructor. If course requirements are not completed within the period indicated, a grade of "F" will be recorded, and the student's GPA will be adjusted accordingly. Students who are fulfilling an Incomplete grade do not register for the course, but make individual arrangements with the instructor who assigned the "I" grade.
