Senate President Salangang requests time for a presentation of proposed new student fee increases by Associate Vice President for Enrollment Management, Barb Roberts, and Director New Student Orientation, Transition and Family Programs, Savannah Baltera.

Senator Johnigan asked how much in total the organization is trying to obtain

Speaker Baltera stated that they would be gaining an additional \$360,000

Senator Johnigan stated that they are against the student fee increase

SPPT Abbo asked approximately how much funding the organization they have over a year and how much they expect to be paying Orientation Leaders

Speaker Baltera stated that the funds do not roll over on this specific account as they have to spend it. Speaker Baltera does not want to quote for the record, but new Orientation Leaders receive \$12.50 and experienced leaders get \$15.00

Chair Arellano asked if there was reason to the \$200 student fee, increase of \$45

Speaker Baltera answered that the increase of funds would allow the organization to grow the program

AG Leon-Martinez stated that they have seen firsthand that the fees are being utilized to the fullest extent

Senator Villaneuva asked when did UNLV decided to do the budget increase, they believe that it isn't justified to compare UNR and UNLV

Speaker Baltera stated that they weren't brought in the conversation so they do not know

Senator Villanueva asked if there were any student input regarding the issue

Speaker Baltera stated that this process is the student input and there is time till the December meeting

Senator Villanueva stated that the admissions experience was better at UNR so they wanted to put it in the record if UNR has a lower budget, and if so, how come they are doing it better

Senator Johnigan advised the Senators to comment on this issue

SPPT Abbo asked if there was a point of contact to ask more about the issue

Speaker Baltera answered that students can email or if CSUN wants to invite them back

Senator Flores commented that undocumented students may have a difficult time paying the student fee increase

Senator Lyons stated that they weren't onboard with the fee increase and asked if there



was any way to reevaluate the current funds

Speaker Baltera answered that they would have to

Senator Lyons asked if the organization exhausted options before increasing the fees

Speaker Baltera stated that they did a lot of research and the timing seemed right to ask for a fee increase

Senator Hankins stated that although they support the budget increase, it is highly unfortunate that the only way to fund this is through the students and that this should be funded in another way

Senator Villanueva is not in favor of the student fee increase, for the record

SPPT Abbo yielded the floor to the member of the public

Hoffman Madzou, Associate Justice for CSUN asked how would it make the student's life easier and help them in the long term

Speaker Baltera stated that the fees are to help students transition though their First Year and retaining students is a critical time, so it is important to give the students the tool

Hoffman Madzou asked why the organization isn't using the reserves instead of the student's fees

Speaker Baltera answered that they can't easily access the reserve

President Franklin stated that they would pay the extra 45 dollars for a great experience in Orientation

AG Leon-Martinez wanted to clarify that this is a one time fee and there is a benefit to the fee
