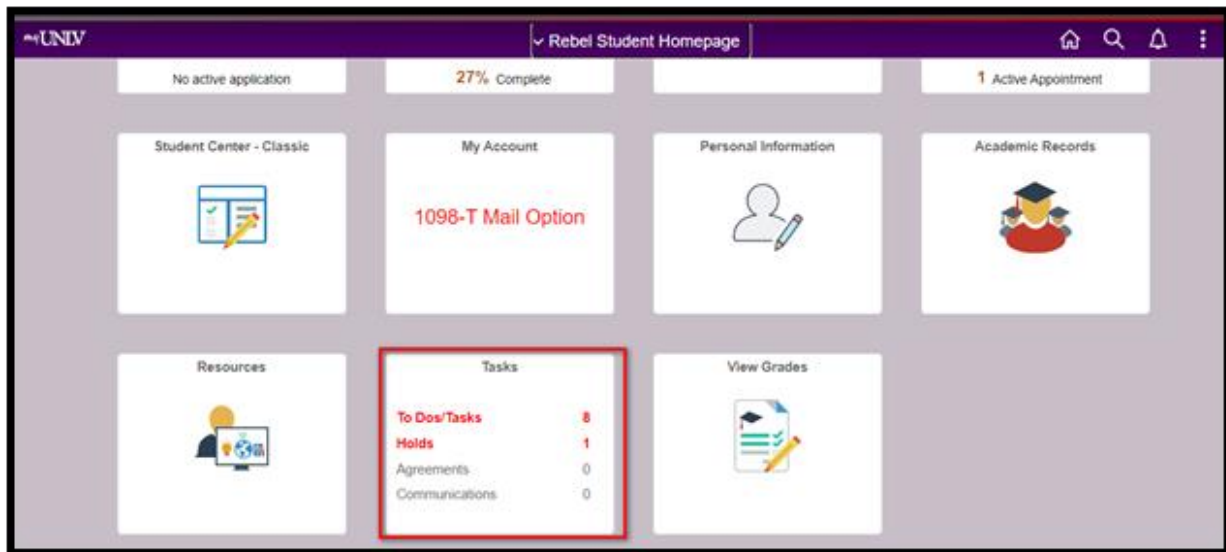


The Online Class Agreement allows students who have not submitted complete Immunization records to enroll in fully web-based classes for each term. A new online Enrollment Agreement would need to be completed each term in which a student does not have the requisite immunizations required for enrollment on campus. This agreement restricts students to classes that are Web-based or Web-live, and have NO in person components (meetings/exams/etc). 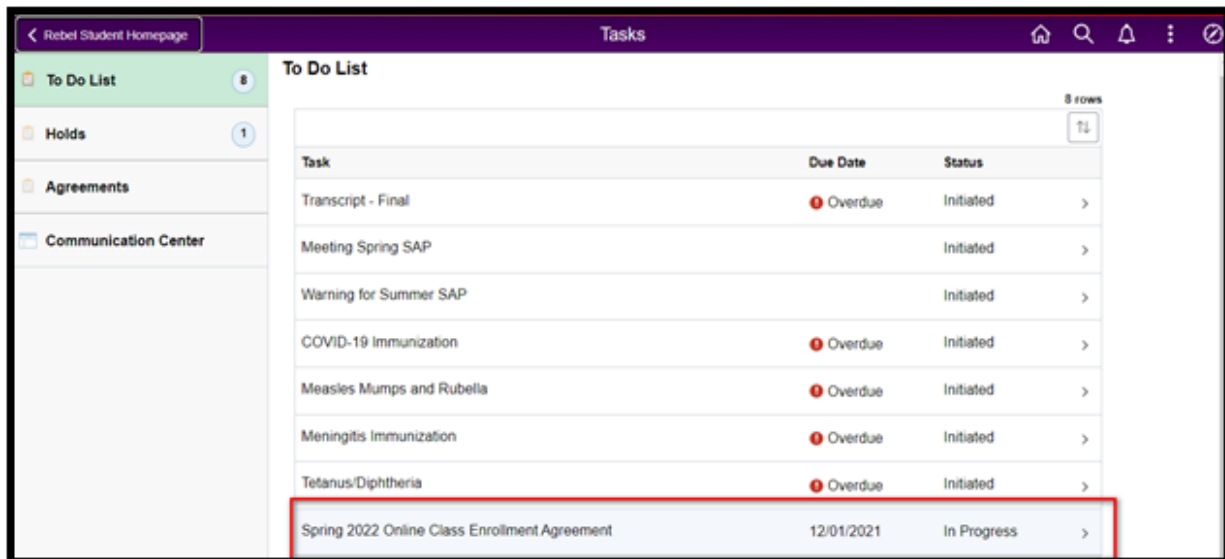
Students with outstanding immunization requirements will be asked to complete the agreement by either [Accepting](#) or [Declining](#) the terms. If a student has completed the online enrollment agreement and would like to enroll in in person classes, they should submit proof of the Immunization requirements. Once those are processed it will lift the restriction from the student's account.

Completing the Online Enrollment Agreement

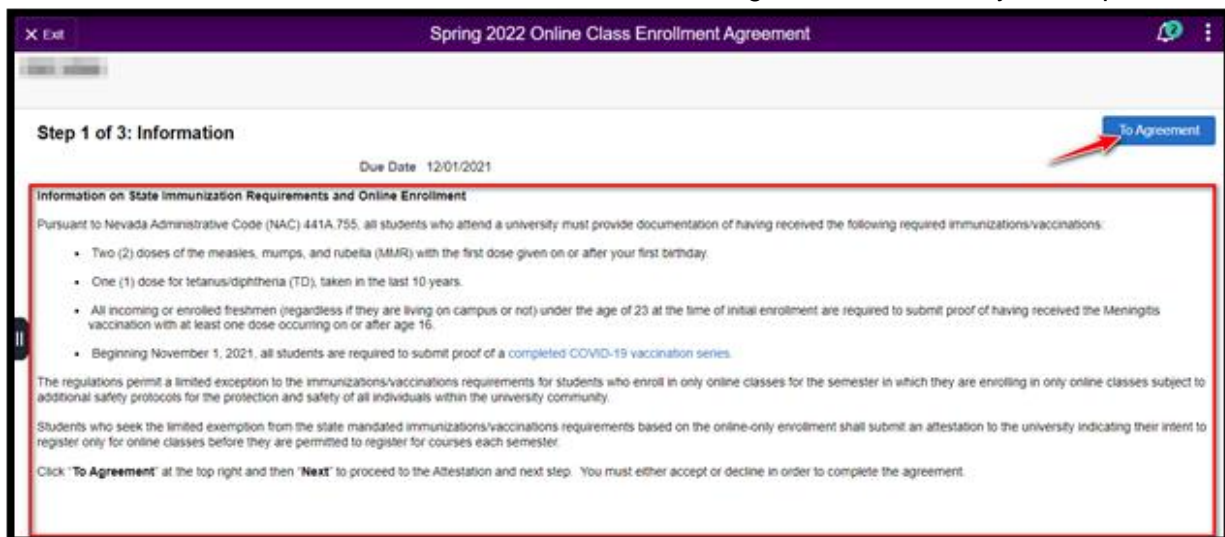
1. Click Tasks on the Rebel Student Homepage



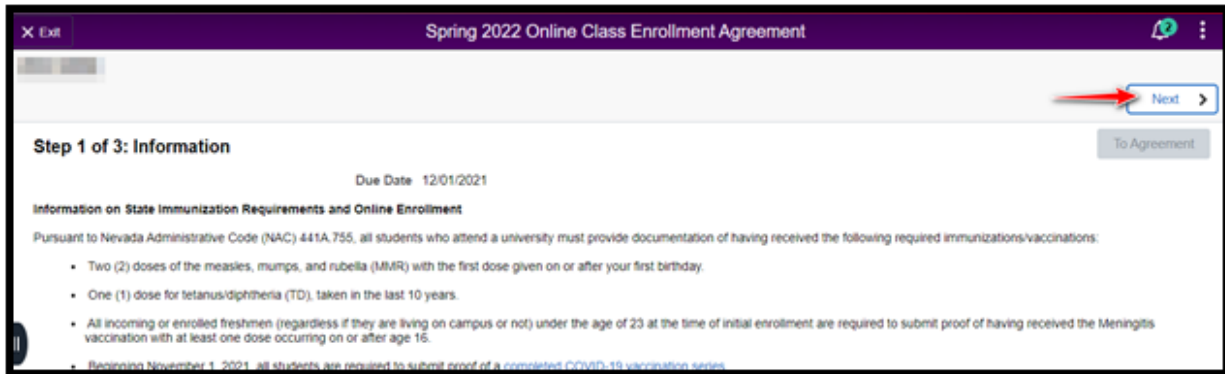
2. Click on the Online Class Enrollment Agreement for the correct term



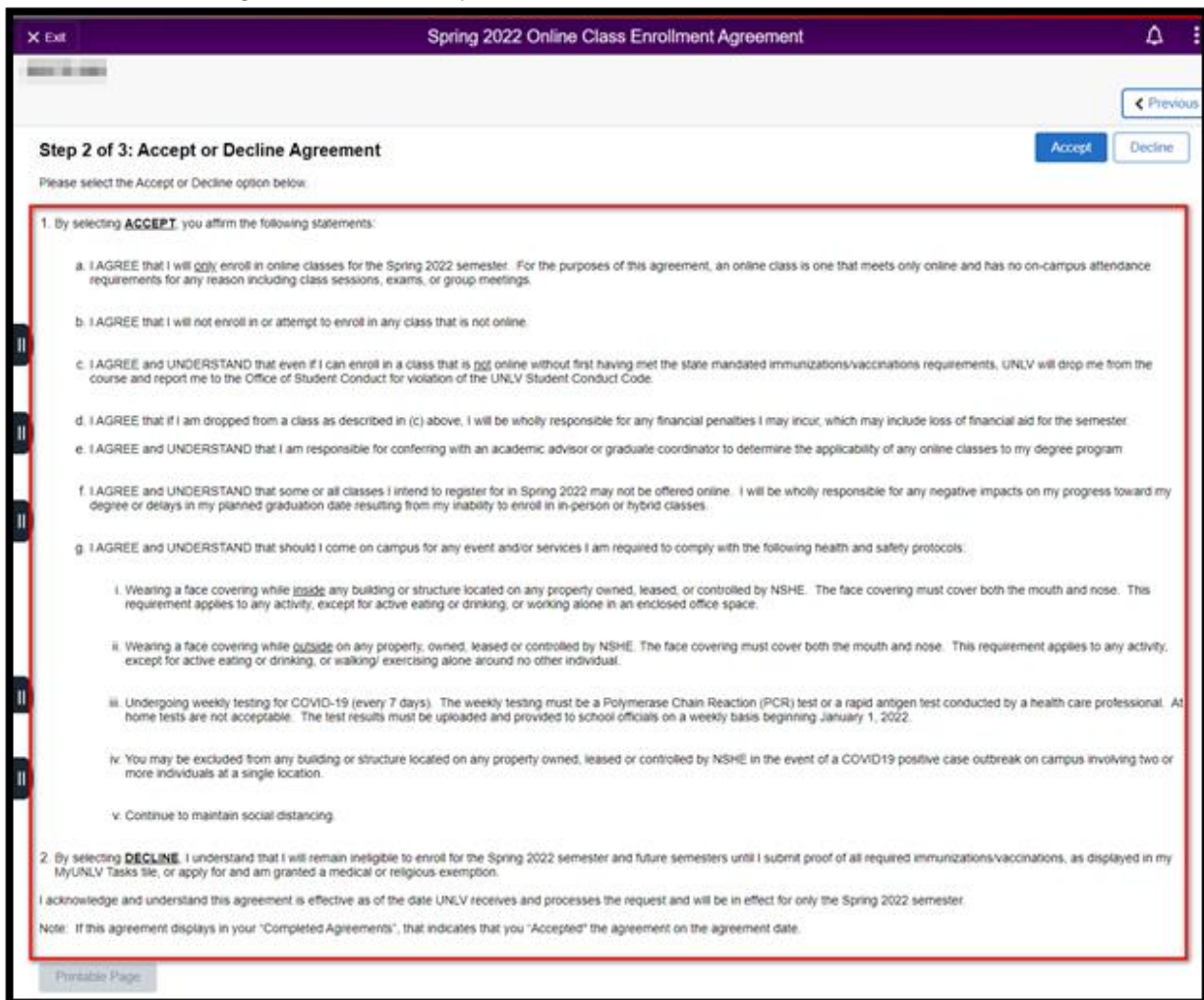
3. Review the information and then click To Agreement to select your response



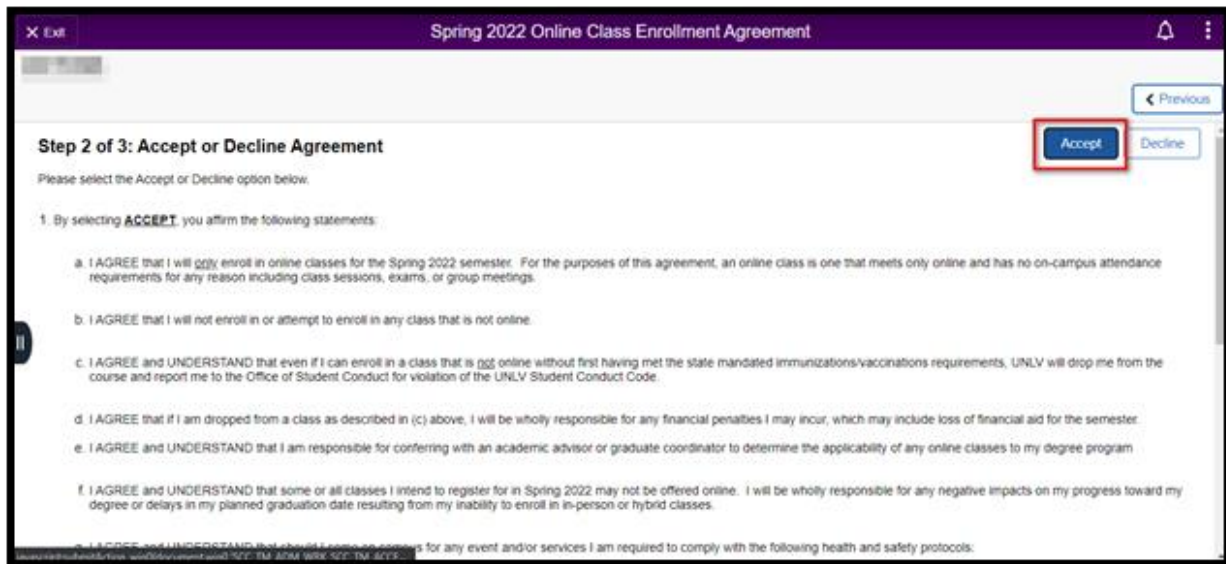

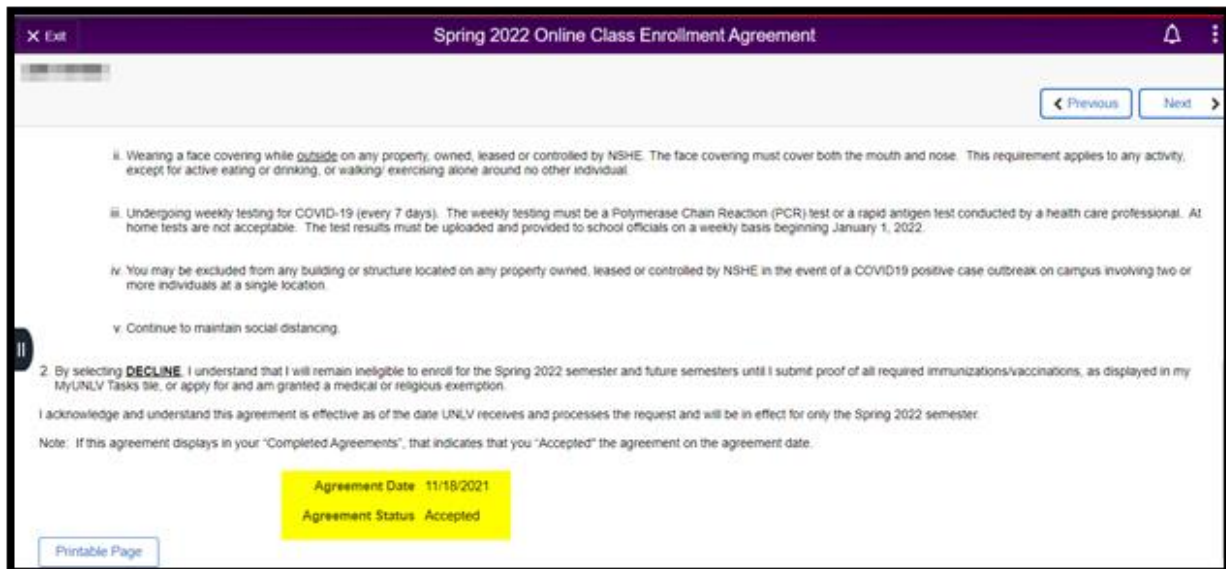
