**SENATE BILL 55-23**

---

**AN ACT TO AMEND THE CSUN BYLAW CHAPTER 402 SECTION 4**

**WHEREAS**, the Consolidated Students of the University of Nevada (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; **AND**

**WHEREAS**, the Senate of the Consolidated Students of the University of Nevada, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

**WHEREAS** student organizations are critical to building community, fostering student leadership, and enhancing campus life; **AND**

**WHEREAS** CSUN has a longstanding mission to support student engagement, and recognizes that student organizations are critical to building community, fostering student leadership, and enhancing campus life through events, advocacy, and service; **AND**

**WHEREAS**, the CSUN Ways and Means’ main objective is to serve as a supplemental source of monetary funds to Registered Student Organizations on campus; **AND**

**WHEREAS**, CSUN’s Ways and Means Committee is responsible for allocating funding to Registered Student Organizations (RSOs), which play a vital role in supporting student interests and involvement; and

**WHEREAS**, ensuring a stable and sufficient percentage of the CSUN budget is dedicated to RSO funding reflects CSUN’s commitment to transparency, student empowerment, and equitable access to campus resources,

**LET IT BE ENACTED** that the CSUN Bylaws be amended that CSUN Bylaw Chapter 402, Section 04 be amended as shown in addendum A:

**ADDENDUM A**

## SECTION 04: EXPENDITURES AND LIMITATIONS

- A. The Annual Operating Budget shall account for all operational expenditures of CSUN. No funds contained in the Annual Operating Budget shall be used for capital spending unless the Senate explicitly provides for such capital spending by law.
- B. Total CSUN compensation, paid to officers or officials, shall not exceed 22.5% of the total annual CSUN budget.
- C. No less than thirty percent (30%) of the total annual CSUN budget shall be allocated to funding for the Student Organizations Funding Line item.*
