EXECUTIVE BILL 54-02

**AN ACT TO AMEND THE CSUN BYLAWS TO CREATE AN ANNUAL
STUDENT ASSOCIATION FEE ASSESSMENT**

WHEREAS, the Consolidated Students of the University of Nevada (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; **AND**

WHEREAS, the Senate of the Consolidated Students of the University of Nevada, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

WHEREAS, an annual assessment of the CSUN Student Association Fee is required per the Constitution, Article II, B ; **AND**

WHEREAS, CSUN must proactively ensure that fee allocation is transparent and easily accessible to the student body; **AND**

WHEREAS, CSUN must maintain an environment of consistent honesty and education with the student body that this student government is designed to represent; **AND**

WHEREAS, it is the duty of this student government to improve its current fee education system and maintain a system of ethical and transparent reporting on fee usage; **AND**

THEREFORE, BE IT ENACTED that the proposed changes under ADDENDUM A will establish an official annual fee review process and provide succeeding presidents with the ability to gauge CSUN’s financial health.

CHAPTER 408: ANNUAL STUDENT ASSOCIATION FEE ASSESSMENT

SECTION 01: ESTABLISHMENT

- A. *As outlined in Article II of the Constitution, a review of the CSUN Student Association Fee must occur annually, which will inform the President's decision whether or not to pursue an increase to the CSUN Student Association Fee for the subsequent academic year.*

SECTION 02: WORKGROUP ON STUDENT ASSOCIATION FEE ASSESSMENT

- A. *There is hereby established a Workgroup on Student Association Fee Assessment for the purpose of advising the President on whether or not to pursue an increase to the CSUN Student Association Fee for the subsequent academic year.*
- B. *The Workgroup shall be composed of the President, who shall be its chair, at least two members of the Executive Branch, at least two members of the Legislative Branch, and at least one undergraduate student not currently serving a role within CSUN.*
 - 1. *With the exception of the President, members of the Workgroup must be confirmed by the Senate for a term beginning on or after May 1 and ending on September 30.*
- C. *As soon as all members of the Workgroup have been appointed, the Workgroup shall schedule a meeting within 14 calendar days to receive a report from the CSUN Business Manager regarding the annual operating budget and expenditures for the previous, current, and upcoming academic years.*
- D. *By August 15 of each year, the Workgroup must then schedule a meeting with the Vice President for Student Affairs to discuss the status of CSUN's finances and current CSUN Student Association Fee.*
- E. *At the first Senate meeting of the fall semester, the President must present a report to the Senate summarizing the fiscal state of CSUN and the President's decision as to whether or not an increase to the CSUN Student Association Fee should be pursued for the following academic year.*
 - 1. *If the President recommends pursuing an increase to the CSUN Student Association Fee, then the Senate must either approve or deny the request by September 20.*

SECTION 03: FEE INCREASE REQUEST TO BOARD OF REGENTS

- A. *If a fee increase is to be pursued the President, in consultation with the Vice President for Student Affairs, must submit the Board of Regents agenda item request to the UNLV President's office by September 30.*

SECTION 04: PUBLICATION OF THE FEE

- A. *It shall be the duty of the CSUN Advisor to ensure that the CSUN Student*

*Association Fee is published on the CSUN website in accordance with Article II,
Section B(2) of the Constitution.*
