EXECUTIVE BILL 54-03

AN ACT TO AMEND THE CSUN BYLAW CHAPTER 107: INTERNSHIP PROGRAM

WHEREAS, the Consolidated Students of the University of Nevada (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; **AND**

WHEREAS, the Senate of the Consolidated Students of the University of Nevada, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

WHEREAS, CSUN must actively foster an environment of consistent growth and opportunity among the undergraduate population; **AND**

WHEREAS, it is the duty of this student government to actively promote and incentivize participation in this government through active involvement of the student body ; **AND**

WHEREAS, CSUN must ensure that students are compensated for their service to student government through meaningful financial support; **AND**

THEREFORE, BE IT ENACTED that the proposed changes, as outlined in ADDENDUM A, authorize a scholarship for students successfully completing the CSUN Internship program.

ADDENDUM A

SECTION 11: GRADUATION FROM THE PROGRAM

A. Participants who have completed the capstone project for their ~~perspective-~~
respective branch may be granted graduation.

B. Upon graduation, participants shall have the opportunity to:

1. Continue in the branch
2. Select a different branch
3. No longer be part of the program

E. Interns who successfully graduate from the program will be awarded a monetary scholarship from CSUN of \$250. Scholarships will be awarded for completion of the program, irrespective of how many mentors they choose to shadow.

F. The total annual allocation for the Internship Program Scholarship shall not exceed \$5,000, subject to availability in the CSUN General Budget, and shall not exceed a total of 20 interns across all three branches.

H. Eligibility for the scholarship through completion of the internship program shall be verified by the following liaisons based on assigned branch:

- 1. Executive: President, Vice President, or Attorney General*
- 2. Legislative: Senate President Pro Tempore*
- 3. Judicial: Chief Justice or Associate Chief Justice*

I. The CSUN Executive Board shall present an annual report to the Senate detailing scholarship disbursements and program outcomes.
