EXECUTIVE BILL 55-02

AN ACT TO AMEND CSUN BYLAW TITLE VIII: SCHOLARSHIPS

WHEREAS, the Consolidated Students of the University of Nevada Las Vegas (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; **AND**

WHEREAS, the Senate of the Consolidated Students of the University of Nevada Las Vegas, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

WHEREAS, CSUN must actively advocate for the financial needs of undergraduate students through means of scholarships; **AND**

WHEREAS, under Title VIII of the CSUN Bylaws, Chapter 822 will be added; **AND**

WHEREAS, after discussion and approval from committee members during S&G 55-13 funds have been approved for reallocation within the FY 2026 Organization Budget for an amount not to exceed \$10,000 from the FY 2026 Organization Budget; **AND**

THEREFORE, BE IT ENACTED, CSUN shall appropriate \$10,000 to fund the Summer Term Scholarship, and that the following bylaw edits shall reflect the CSUN Scholarship program for the 2025-2026 academic year and onwards; until potential changes are proposed through the CSUN Scholarships and Grants Committee and approved by the CSUN Senate.

ADDENDUM A

CHAPTER 820: UNLV CSUN SUMMER TERM SCHOLARSHIP

SECTION 01: ESTABLISHMENT

A. There is hereby established the UNLV Summer Term Scholarship for the purpose of aiding students in the pursuit of education throughout a UNLV academic summer semester.

SECTION 02: AWARD

- A. This scholarship will be awarded to 10 (ten) UNLV undergraduate students at \$1,000 (one thousand dollars) each, which will be dispersed over 1 (one) academic summer semester.*
- B. Open to all students who meet all of the eligibility requirements found below regardless of citizenship status.*

SECTION 03: ELIGIBILITY

- A. Awardees must meet the following criteria:*
- 1. Must be an undergraduate student at UNLV.*
 - 2. Must be enrolled in 3 or more credits during the UNLV summer semester.*
 - a. This point of eligibility will be verified through the UNLV Office of the Registrar and Enrollment Management as well as the Financial Aid Office.*
 - b. Any information provided with regards to this scholarship will only be used for the purpose of scoring and will not be shared with outside sources, unless otherwise permitted by the applicant or the information provided suggests a clear and present danger to the applicant or other students.*
 - 3. Must maintain a 2.50 GPA or higher throughout the duration of the scholarship disbursement period.*
 - 4. Must complete the FAFSA or Alternative Need Form before completing the application*
- B. The CSUN Scholarships & Grants committee has the right to request that exceptions be made to any requirements and this decision must be decided through a simple majority vote to be taken within the committee. This request must be communicated with the CSUN Business Manager who will then be able to contact the Financial Aid Office regarding the exception.*
