A complaint has been submitted against Senator Corey Gerwaski. The committee will decide if the complaint warrants an Internal Affairs Investigation.

#### **i. Investigation and Recommendation of an Internal Affairs Complaint against Corey Gerwaski**

A complaint has been submitted against Senator Corey Gerwaski. The Committee will investigate the potential complaint regarding Senator Corey Gerwaski. Investigation will involve questioning of parties and witnesses, along with requests for information. Resolution will be determined in the following agenda item. Following the investigation, the committee will decide if the complaint warrants an Internal Affairs Investigation.

*Chair Thomas explains the process of an IA Complaint*

*Senator Gerwaski calls a point of order about the agenda, specifying that it is a determination whether a case is necessary, and the purpose of the meeting*

*Attorney General Rejas offers more clarification of the agenda and advises Chair Thomas to read the complaint*

*Chair Thomas offers more clarification on the agenda item and reads out the two complaint forms listed in the drive. The verbal reading of the complaints can be found in the drive*

*Senator Gerwaski raises a point of order about the format in which the Chair is conveying the alleged allegations and requests that he can respond to complaints.*

*Attorney General Rejas reclarifies his request for Chair Thomas to read the complaints*

*Chair Thomas states that we will read both complaints and then open the floor to discussion*

*Chair Thomas reads out the second complaint form listed in the drive. The verbal reading of the complaints can be found in the public recording located in the drive*

*Senator Gerwaski raises a point of order about the format in which the Chair is conveying the alleged allegations, stating that allowing speeches would imply an investigation and requests that he can respond to complaints.*

*Dr. DMC requests to speak to the Chair to clarify procedure*

*Chair Thomas calls a voice vote on to a period of voting for a 5-minute recess.*

*Attorney General Rejas raises a question about the protocol of the meeting*

***With a vote 8-0-0, the committee takes a 5-minute break at 5:45***

***At 5:50, the committee reconvenes.***

*Chair Thomas explains the procedure for an IA complaint, after the complaints are read aloud, the complainant and the respondent both have time for a speech, and the committee holds a discussion as to determine whether action will be taken*

*Senator Gerwaski and Dr. DMC take a point of personal privilege 5:54pm*

*Attorney General Rejas explains that these accusations are alleged*

*Senator Morfinez-Solis asks if the Chair can take a look at his speech*

*Chair Thomas: Yes*

*Senator Curry: states that we can go to period of recess*

*Attorney General Rejas: States that the Chair and Student Body President can reach out to Senator Gerwaski*

*Chair Thomas calls a voice vote on to a period of voting for a 5-minute recess*

***With a vote 8-0-0, the committee takes a 5-minute recess at 6:00***

***At 6:08 the Committee resumes the meeting***

*Chair Thomas goes to a period of roll call*

*Vice Chair: Shaw present*

*SPPT: Ibarra Lira present*

*With 8 Senators present, a quorum is met*

*Morfinez-Solis: Gives a speech regarding the IA complaint. The verbal recording can be found in the public drive*

*Gerwaski: Gives a speech regarding the IA complaint. The verbal recording can be found on the public drive*

*Senator Curry motions to extend the candidate's time by 5 minutes*

*Senator Brooks Seconds*

*with a vote of 8-0-0, the defendants time is extended*

*Gerwaski continues his speech.*

*Senator Curry: To both complainant and respondent, what have you done to bridge communication*

*Senator Gerwaski: explains that he has gone to the Senate leadership, Senate President Abbo, with no response, talked to Senate President Flores, to host an intervention. Has also sent emails to both engineering senators*

*Senator Morfinez-Soliez: explains that he has gone to Senate President Abbo, and President Dias. Explains that the emails regarding the scholarship came after filing the IA report*

*Senator Gerwaski: Clarifies that the lack of communication came from the recommendation of the intervention. Clarifies that his social media is proof of his abilities to stay unbiased*

*Senator Brooks: States that the issue seems internalized between the engineering senators, asks if it is possible to have the listed potential witnesses involved, and states that there is only one side of the evidence included in the drive*

*Chair Thomas: Asks if Gerwaski can send proof of complaint*

*Senator Gerwaski: Gives specific dates about the emails and the scholarship*

*Senator Curry: Would Gerwaski be willing to compromise on the social media pages*

*Senator Gerwaski: Clarifies that the social media was to show that his actions are what matter, not what is posted. States that he is fine with compromising and deleting it*

*Senator Shaw: asks the complainant where the cited Code of Conduct and Bylaw and violations are located as they are unable to be located on the recent versions of the Constitution, Code of Conduct, and Bylaws*

*Senator Morfinez-Solis: cited that the complaint was issued a "while ago", it could have changed*

*Senator Shaw: explains that the code of conduct rules haven't changed and asks the Chair if an investigation is opened, what would be opened to the committee*

*Chair Thomas: explains the process of an investigation*

*Senator Morfinez-Solis: gives a verbal account of the timeline of communications with the engineering Dean and Gerwaski*

*Senator Gerwaski: raises a point of order about the lack of evidence.*

*Senator Morfinez-Solis: continues with his testimony*

*Chair Thomas: raises a point of order that they will be focusing on speeches*



*Senator Hankins: Feels that both parties are sharing evidence that is not present in the supplemental materials, and third-party details are being shared*

*SPPT: Ibarra Lira: Echoes that this meeting is fueled with emotion, and if an investigation is opened, that both parties should be involved. Additionally, he feels that the engineering dean shouldn't take sides in CSUN affairs.*

*Senator Brooks: Explains that she prefers visual proof of the communications with Dean Venkat*

*Senator Gerwaski: agrees that Dean Venkat should not take sides in CSUN Affairs. Explains his frustration with the complainant's reaction to the scholarship and states his frustration.*

*Chair Thomas: asks if the defendant can share screenshots of the incident*

*Senator Gerwaski: explains that the screenshots of the incident might violate FERPA due to the financial nature of the incident.*

*Senator Brooks: asks if the chair can revisit this item at a later date.*

*Chair Thomas: explains that it may be difficult, and feels that a decision must be made in this meeting.*

*Senator Gerwaski: states that he has shared the materials requested with the Chair through Google Chat*

*Attorney General Rejas: Advise that if any new evidence is supplied to the committee, it may violate Nevada Open Meeting Law.*

*Senator Gerwaski: asks if materials requested by the committee can be used to circumvent the note.*

*Attorney General Rejas: feels that it would be fair if all evidence were present at the start of the meeting.*

*Vice Chair Shaw: asks if we can table the item*

*Senator Curry: asks the Chair if the item can be tabled if it's not a bill. And asks if the two parties related to the complaint would be willing to attempt to mend bridges.*

*Senator Gerwaski: states that he believed the intervention held by the three engineering senators was that attempt*

*Chair Thomas states he would have preferred to have a one-on-one with both parties as it would have possibly prevented the current meeting*

*Senator Morfinez-Solis explains his negative experiences with the one-on-one*

*Senator Gerwaski states that the experiences are not accurate*

*Senator Brooks agrees that this is an internal to the engineering senators and asks if this item can return to the IA committee. and asks the two parties how both parties can make amends.*

*Senator Curry explains that he does not believe it is possible to table the item as it is not a bill.*

*Senator Brooks restates her question about what the senators believe they need*

*to move forward.*

*Senator Morfinez-Solis explains that his thoughts and his needs moving forward*

*Senator Gerwaski explains his thoughts and his needs moving forward*

*Attorney General Rejas explains that he advises that the committee can table the item*

*Senator Curry asks if the senator would be willing to meet once in a while to discuss grievances*

*Senator Morfinez-Solis is open to the resolution*

*Senator Gerwaski agrees but wants a neutral third party. Suggests OMBUDS on campus*

*Senator Brooks agrees that a neutral third party to keep things civil.*

*Senator Curry asks Attorney General Rejas if it is possible to table the item.*

*Senator Curry tables the agenda item pending a peaceful resolution between the 3 parties.*
