Chair Curry requests time for the Discussion and Approval of Senate Bill 55-19 For a funding request of no more than \$7,023.00 submitted by UNLV PGA Golf Management Student Association, all costs must be encumbered from the CSUN FY24 Student Organization Line. Senate Bill 55-19 may be found in the CSUN Legislation Record. The request may be subject to amendment at the discretion of the committee

Members from the UNLV PGA Golf Management Student Association are present and give presentation

Chair Curry mentions new UNLV PGA Golf Management Student Association E-board reaching out to Ways and Means

Chair Curry states that the current budget proposed is higher than the original budget request

Members from the UNLV PGA Golf Management Student Association ask for clarification

Chair Curry give clarification and states that the RSO would have to remove items from their budget

Senator Perez-Martinez states they would like to review the other RSO on the agenda as their current membership would reduce the funding amount and could be provided to the UNLV PGA Golf Management Student Association

Senator Perez-Martinez states that the RSO would have to come back again in order to receive the additional funding

Chair Curry states that they see a total of 50 members on the Involvement Center

Senator Shaw asks the Members from 91.5 HD2 - The Beat, if they are an NSHE supplier

Members from 91.5 HD2 - The Beat state yes

Senator Perez-Martinez asks if Advisor Wayand can check the membership total of the RSO

Advisor Wayand states yes, the RSO originally reported 31 total members

Members from 91.5 HD2 - The Beat, give clarification to their current membership total

Advisor Wayand states that the committee can take either the number given from the RSO or the number given from the Involvement Center when it comes to membership total

Senator Shaw ask about membership total on the involvement center

Advisor Wayand states 50

Senator Perez-Martinez ask how the RSO decided that their current membership total is at 32 members

Members from 91.5 HD2 - The Beat give clarification

Senator Perez-Martinez Members from 91.5 HD2 - The Beat, if all their members have paid their dues

Members from 91.5 HD2 - The Beat give clarification on how many members paid dues

Chair Curry mentions that the RSO cut their budget to meet the requirements

Members from 91.5 HD2 - The Beat give clarification on how funding is vital to them

Senator Rejas asks if the Department of UNLV sponsors the RSO

Members from 91.5 HD2 - The Beat state they are not funded by the Department of UNLV just by Greenspun

Chair Curry states that the funding limits are at the discretion of the committee

Senator Perez-Martinez states the membership count is low for the amount of funding

Members from 91.5 HD2 - The Beat gives more clarification of membership and their numbers

Senator Rivera-Gaytan states they are willing to take the membership count from the RSO and states they are in support of the current budget proposal

Senator Shaw states that they are willing to fund the RSO at the amount being asked

Senator Perez-Martinez gives clarification of the maximum amount the RSO is able to receive due to their member count and why membership count is important

Senator Shaw asks if the RSO would be willing to cut any budget item

Members from 91.5 HD2 - The Beat state they would be willing to cut one of the promotional items

Senator Rejas asks Chair Curry if the current operating policy follows the involvement center's membership numbers

Chair Curry gives states that the committee normally looks at the membership total on the involvement center

Senator Perez-Martinez states they see an issue with the RSO collecting dues

Senator Perez-Martinez asks the RSO about shirt quantities and who gets them

Members from 91.5 HD2 - The Beat states they would go to the members

Chair Curry asks if shirt would go to undergrads

Members from 91.5 HD2 - The Beat state yes

Senator Shaw asks if the shirt cost are proportional

Members from 91.5 HD2 - The Beat states that the cost would go up if the shirt quantity goes down

Chair Curry asks if there are any more questions

Senator Perez-Martinez states that due to current operating policy the RSO membership count will be from the involvement center

Senator Rivera-Gaytan states they are fine with funding at the current asking amount

Senator Shaw states they understand with membership count not always being accurate and are fine with funding the current budget proposal

Senator Perez-Martinez states they are fine with funding the total shirt count
