STATE FUNDING FOR CANNABIS RESEARCH

Many states have funded cannabis research through academic institutions and state agencies to support evidence-based policymaking related to legalization, examine public health outcomes, research the medical implications of cannabis use, and more. State funding is necessary and important as federal funding for cannabis research is greatly limited due to its Schedule I placement on the Controlled Substances Act.

In 2022, the National Institutes of Health (NIH) surveyed researchers about interest in and barriers to conducting cannabis research. Researchers identified lack of funding as the top barrier.¹

A March 2025 paper published in the Journal of Cannabis Research examines the cannabis research funding made available in states with legalized cannbis (both recreational and medical)². The paper found that 17 of 38 states that have passed medical or recreational cannabis laws have legislation that funds cannabis research. Of these 17 states, six distributed funds directly to an academic institution with five others relying on state agencies for distribution and one state, California, distributing research funding through both channels.
