SENATE BILL 55-24

**AN ACT TO AMEND THE CSUN BYLAW CHAPTERS 1202, 1203, AND
1219**

WHEREAS, the Consolidated Students of the University of Nevada (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; **AND**

WHEREAS, the Senate of the Consolidated Students of the University of Nevada, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

WHEREAS, the University Initiatives Committee under the Legislative Branch of CSUN serves with the purposes of strengthening the UNLV community, advocating for student interests, needs, and concerns, and ensuring that all voices are being heard by addressing issues of (but not limited to) health, safety, overall student welfare, and social justice; **AND**

WHEREAS, CSUN Sponsorships play a vital role in supporting essential UNLV departments and initiatives that impact the undergraduate student body; **AND**

WHEREAS, under Chapter 1200 of Title XII of the CSUN Bylaws, the CSUN Sponsorship Fund is established to provide recurring financial support to UNLV entities; **AND**

THEREFORE, BE IT ENACTED, that the amendments proposed to the CSUN Bylaw Chapters 1202, 1203, and 1219 aim to enhance student support services provided by the Office of Student Support And Advocacy, which includes the UNLV Food Pantry, UNLV Hope Scholars, and UNLV Fostering Scholars programs; **AND**

BE IT FURTHER ENACTED, that the following amendments to the CSUN Bylaw Chapters 1202, 1203, and 1219 be adopted to reflect the changes outlined in Addendum A.

CHAPTER 1202: UNLV ~~FOOD PANTRY~~ STUDENT SUPPORT AND ADVOCACY SPONSORSHIP

SECTION 01: PURPOSE

A. To provide a permanent funding mechanism for the sponsorship of the ~~UNLV Food Pantry~~ *Office of Student Support And Advocacy, which encompasses the UNLV Food Pantry, HOPE Scholars, and Fostering Scholars programs.*

~~B. To pay for wages for the food pantry's student workers.~~

SECTION 02: FUNDING

A. Each summer at the beginning of the new fiscal year, an amount of ~~twenty-five thousand dollars (\$25,000)~~ *sixty-five thousand dollars (\$65,000)* from the CSUN Sponsorship Budget received from student fees shall be transferred to the ~~UNLV Foundation~~ *Office of Student Support and Advocacy, specifically earmarked for the UNLV Food Pantry from the CSUN Sponsorship budget. It shall be under the discretion of the aforementioned office to distribute the funds as deemed necessary between the UNLV Food Pantry, HOPE Scholars, and Fostering Scholars programs.*

SECTION 03: REQUIREMENTS

A. CSUN's name shall be featured prominently on all sponsored marketing material:

1. Either an official CSUN logo or the words "UNLV CSUN" shall appear on ~~pantry sponsored~~ *marketing materials prepared by the UNLV Food Pantry, HOPE Scholars, and Fostering Scholars* programs that receive funding from CSUN.
2. For purposes of this section, marketing materials shall be defined as shirts, flyers, or any other materials designed to promote.

B. It is the responsibility of the current Chair of University Initiatives to contact the ~~UNLV Food Pantry~~ *Office of Student Support and Advocacy* prior to March 31st of each fiscal year to present them with the most recent copy of their sponsorship.

C. All funds not expended by the UNLV Office of Student Support And Advocacy for any and all purposes outlined within this chapter shall be returned to the CSUN Sponsorship budget on or before June 30 of each calendar year.

~~CHAPTER 1203: UNLV HOPE SCHOLARS SPONSORSHIP~~

~~SECTION 01: PURPOSE~~

~~A. To create a permanent funding mechanism for UNLV HOPE Scholars Program.~~

~~SECTION 02: FUNDING~~

~~A. Each July, an amount of twenty thousand dollars (\$20,000) from the CSUN Sponsorship Budget received from student fees shall be transferred to the UNLV HOPE Scholars Program from the CSUN sponsorship budget.~~

~~SECTION 03: REQUIREMENTS~~

~~B. Each fiscal year, the UNLV HOPE Scholars Program shall send a representative of the Hope Scholars Program to the University Initiatives Committee to present a budget that meets these requirements and justifies the continued sponsorship of the UNLV HOPE Scholars Program. Once approved by the University Initiatives Committee, an amount not to exceed \$20,000 will be transferred to the UNLV HOPE Scholars Program.~~

~~CHAPTER 1219: FOSTERING SCHOLARS PROGRAM SPONSORSHIP~~

~~SECTION 01: PURPOSE~~

~~A. To create a permanent funding mechanism for UNLV's Fostering Scholars Program.~~

~~SECTION 02: FUNDING~~

~~A. Each July, an amount of twenty thousand dollars (\$20,000) from the CSUN Sponsorship Budget received from student fees shall be transferred to the UNLV Fostering Scholars Program from the CSUN Sponsorship Budget.~~

~~SECTION 03: REQUIREMENTS~~

~~A. At the request of the Chair or Vice Chair, the UNLV Fostering Scholars Program shall send a representative of the Fostering Scholars Program to the University Initiatives Committee to present a budget that meets these requirements and justifies the continued sponsorship of the UNLV Fostering Scholars Program. Once approved by the University Initiatives Committee, an amount not to exceed \$20,000 will be transferred to the UNLV Fostering Scholars Program.~~

~~B. Funding received by the UNLV Fostering Scholars Program shall go to providing coaching and support funding at UNLV for eligible UNLV students, who have been in foster care since the age of 13.~~

~~C. Representatives from the UNLV Fostering Scholars Program shall provide various reports to CSUN~~

~~1. Give a report on the UNLV Fostering Scholars Program's use of the sponsorship budget once in the Fall semester and once in the Spring semester.~~

~~D. CSUN's name shall be featured prominently on sponsored marketing material.~~

- ~~1. Either an official CSUN logo or the words "UNLV-CSUN" shall appear on sponsored marketing materials prepared by the UNLV Fostering Scholars Program or CSUN.~~
- ~~2. For purposes of this section, marketing materials shall be defined as shirts, flyers, or any other materials designed to promote.~~

~~E. It is the responsibility of the current Chair of University Initiatives to contact the UNLV Fostering Scholars Program prior to March 31st of each fiscal year to present them with the most recent copy of their sponsorship.~~

~~F. All funds not expended by the UNLV Fostering Scholars Program at UNLV for any and all purposes outlined within this chapter shall be returned to the CSUN Sponsorship budget on or before April 30 of each calendar year.~~
