*Senator Tuitele returns from point of personal privilege at 5:38 pm*

*Chair Curry opens the floor to questioning.*

*Senator Prieto notes that the RSO is over the budget. They requested almost 4,000 dollars over the budget.*

*The RSO says that they have a big impact on campus and would like to stay over the cap because they do so much and have over 200 members.*

*Chair Curry notes that the reason our budget is 12,500 is because we want to spread the money around. We will not go over the maximum budget for this RSO when we haven't for others this fiscal year.*

*Senator Brooks notes that the RSO's budget is very vague and does not contain exact quotes for cultural food, just estimated amounts.*

*The RSO explains that this is because they do not know what they will be catering before the event actually comes.*

*Senator Brooks also notes that the cultural candy is vague as well as line item 12 "decorations". Previously, we have not funded "decorations" without exact quotes. Line items 13 and 14 are also vague, it is not itemized.*

*Chair Curry explains that we need to be specific because if we receive an audit, we must know exactly where the money is going. We must be transparent to our constituents.*

*We keep "cultural food" but remove cultural candies, cultural toys, and ingredients for cooking. This moves their budget down to just under 13,000 dollars.*

*We also remove "decorations" which bring it to just over 12,600 dollars.*

*The RSO decides to remove funding from “cultural food” until the budget reaches 12,500 on the dot.*

*Vice Chair Coss moves to amend senate bill 55-95 to read “**WHEREAS**, the student organization, after being seen by the Ways and Means Committee, has been approved for an amount not to exceed \$12,500.00; **THEREFORE, BE IT ENACTED**, CSUN shall appropriate \$12,500.00 onetime to fund the Food Tasting Club and where all costs are to be encumbered from the CSUN FY 25-26 Student Organization Funding Budget in adherence with the Ways and Means Operating Policy” and to amend addendum A to reflect the updated budget sheet.*

*Vice Chair Coss asks if line item 8 is a subscription – which cannot be funded.*

*Chair Curry notes that we cannot fund “credits” because it is not transparent. We cannot see what these credits are being used for exactly.*

*The RSO explains what the credits will be used for.*

*Senator Coss asks why they asked for these for 2.49 months?*

*The RSO explains that they will only use them for 2.49 months.*

*Senator Brooks expresses confusion about the monthly documentation.*

*Senator Le asks if there is a time limit of when these are being used, she is concerned it could be considered a subscription.*

*The RSO explains they can use them past 2.49 months until they run out.*

*Senator Brooks says that after looking at the quote it is 1,600 for the month, she asks how these months are purchased in “fractions”.*

*Senator Brooks is asking how they can buy a fraction of a month.*

*Senator Brooks asks if these need to be itemized.*

*Senator Hubshman asks if we should list it in the budget as the actual amount of credits.*

*Chair Curry asks if the RSO can give us the exact number of credits they are wishing to buy.*

*Senator Hubshman wants to cut line item 6 in half. It is already cut in half, but needs to be itemized.*

*The RSO gives us a supplier for the food, and notes it actually needs to cut it in half.*

*We cut it in half.*

*AG Rejas gives a suggestion that the supplier should be noted in the budget.*

*Senator Prieto moves to amend senate bill 55-100 to read “WHEREAS, the student organization, after being seen by the Ways and Means Committee, has been approved for an amount not to exceed \$ 5,078.41; THEREFORE, BE IT ENACTED, CSUN shall appropriate \$ 5,078.41 onetime to fund the AI and Data Science Club and where all costs are to be encumbered from the CSUN FY 25-26 Student Organization Funding Budget in adherence with the Ways and Means Operating Policy.”*
