EXECUTIVE BILL 55-06

AN ACT TO AMEND THE CSUN BYLAWS AND ESTABLISH A CSUN PROTECTION AND HYDRATION PROJECT

WHEREAS, the Consolidated Students of the University of Nevada (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; **AND**

WHEREAS, the Senate of the Consolidated Students of the University of Nevada, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

WHEREAS, UNLV students regularly face extreme heat and sun exposure, with temperatures often exceeding 100 degrees, especially during outdoor activities and events **AND**;

WHEREAS, Dehydration and lack of sun protection pose preventable health risks to the student body **AND**;

WHEREAS, CSUN is committed to enhancing student life, health, and wellness **AND**;

WHEREAS, This program will serve thousands of students on a recurring basis and provide ongoing visibility for CSUN initiatives by providing gatorade, sunscreen, and handfans with the CSUN logo **AND**;

WHEREAS, The Student Union and SRWC are highly trafficked locations ideal for wellness resource distribution; **AND**

THEREFORE, BE IT ENACTED CSUN shall provide \$8,000 for the CSUN Protection and Hydration Project

ADDENDUM A

CHAPTER 12XX: CSUN PROTECTION AND HYDRATION PROJECT

SECTION 01: PURPOSE

A. To provide hydration and sun protection for students traversing campus in the Nevada heat

SECTION 02: FUNDING

A. Each April, an amount of (\$8,000) eight thousand dollars from the CSUN Sponsorship Budget Line, received from student fees, shall be allocated toward the purchase of Gatorade beverages sunscreen, and hand fans products to be disbursed at the CSUN Student Union Front Desk and Student Wellness and Recreational Center (SRWC) Rebel Wellness Zone.

B. These items shall be distributed to students who show their UNLV student I.D.

SECTION 03: REQUIREMENTS

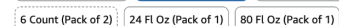
A. Prior to February 1st and May 1st, a representative from both the UNLV Student Union and the UNLV SRWC shall submit a report to the CSUN University Initiatives Committee and CSUN Business Operator. The report shall contain:

- 1. An inventory of products used up to the date of the report*
- 2. If additional support is required for the sponsorship*
- 3. The handfans must have the CSUN logo displayed on the sides*
