#### AN ACT TO AMEND THE CSUN BYLAWS CHAPTERS 405 AND 1304

**WHEREAS**, the Consolidated Students of the University of Nevada (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; **AND**

**WHEREAS**, the Senate of the Consolidated Students of the University of Nevada, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

**WHEREAS**, The CSUN Judicial Council has determined that Chapter 405 of the CSUN Bylaws conflicts with the CSUN Constitution’s definition of “CSUN Officers”; **AND**

**WHEREAS**, According to Article III, Section E of the CSUN Constitution, that the Constitution supersedes all CSUN governing documents; **AND**

**WHEREAS**, CSUN recognizes there must be an amendment to align Chapter 405 of the CSUN bylaws with the CSUN Constitution’s definition of “CSUN Officers”; **AND**

**WHEREAS**, The language of CSUN documents should remain consistent throughout; **AND**

**WHEREAS**, The amendments to the bylaws will reflect the decision of the Judicial Council’s interpretation of Executive Officers; **AND**

**WHEREAS**, It is important for all executive branch members to access the CSUN offices laid out in Bylaw Chapter 1304;

**THEREFORE, BE IT ENACTED**, that the following amendments to the CSUN Bylaws be adopted to reflect the changes outlined in Addendum A and the decision rendered by the Judicial Council in Addendum B.

### **CHAPTER 1304: BUILDING ACCESS**

#### **SECTION 02: ACCESS TO CSUN OFFICES**

A. All CSUN Officials

1. Shall have access to the main entrance to the CSUN Offices during Student Union business hours.

B. Legislative Officers

1. Shall have access to the CSUN Senate Chambers and the CSUN Conference Room.

C. Executive *Branch Members* ~~Officers~~

1. Shall have access to the CSUN Senate Chambers, CSUN Directors Chambers, CSUN Conference Room, and the individual CSUN student offices.


D. Judicial Officers

1. Shall have access to the CSUN Judicial Chambers (located in SU 306) and the CSUN Conference Room.

E. Directors, Associate Directors, Assistant Directors

1. Shall have access to the CSUN Directors Chambers and the CSUN Conference Room.
