EXECUTIVE BILL 55-14

AN ACT TO APPROPRIATE FUNDS FOR CSUN OFFICE FURNITURE UPGRADES

WHEREAS, the Consolidated Students of the University of Nevada (CSUN) represents all 27,000+ undergraduate students enrolled at the University of Nevada Las Vegas; **AND**

WHEREAS, the Senate of the Consolidated Students of the University of Nevada, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

WHEREAS, the Bylaws allow the usage of the Interest Bearing Account whenever “Long-term projects, the benefits of which impact the entire student body.” As stated in Subsection D.1.I under Chapter 402 Section 1; **AND**

WHEREAS, the CSUN Senate Chambers, Directors Chambers, and Conference Room are heavily utilized by CSUN Officers and guests, including Registered Student Organizations (RSOs), university departments, university leadership, student leaders and their constituents; **AND**

WHEREAS, the current furniture in the CSUN Senate Chambers, Directors Chambers, and Conference Room are composed of recycled items from Student Union and Event Services, with multiple chairs and tables in disrepair; **AND**

WHEREAS, Chapter 701.01.A of the CSUN Bylaws establishes that “the UNLV Student Union shall be the permanent seat of government for CSUN,” and Bylaw 701.02.A established that all CSUN offices attached to the seat of government shall operate within the UNLV Student Union; **AND**

WHEREAS, maintaining a professional and functional seat of government enhances CSUN’s ability to serve and represent the undergraduate student body effectively; **AND**

WHEREAS updating the Senate Chambers, Directors Chambers, and Conference Room represents a long term investment in student infrastructure that will benefit future generations of undergraduate students and student leaders; **AND**

WHEREAS a more professional space will improve the experience of campus visitors, university partners, and student organizations engaging with CSUN; **AND**

WHEREAS the Senate Chambers, Directors Chambers, and Conference Room serve as the visible and symbolic centers of student representation at UNLV, where decisions that affect all undergraduate students are discussed and enacted;

THEREFORE, BE IT ENACTED, CSUN shall provide an amount not to exceed \$51,263.84 from the Interest Bearing Account Budget Line for the funding of the CSUN Senate Chambers and Directors Chambers tables, chairs, and fixtures. Any Remaining Funds if not spent shall return to the Interest Bearing Account.
