SENATE BILL 55-130

**AN ACT TO CREATE A ONE-TIME SPONSORSHIP FOR THE UNLV
GLOBAL INTERNATIONAL SUCCESS PROGRAMS**

WHEREAS, the Consolidated Students of the University of Nevada (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; **AND**

WHEREAS, the Senate of the Consolidated Students of the University of Nevada Las Vegas, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

WHEREAS, Section 04 under Chapter 1200 of Title XII of the CSUN Bylaws establishes the ability to “regulate sponsorship funding by establishing guidelines for applicants, approving or disapproving of all applications, and managing ongoing sponsorships”; **AND**

WHEREAS, the University Initiatives committee (under the Legislative Branch of CSUN) serves with the purposes of improving the UNLV campus and community, addressing and advocating for undergraduate student interests, needs, and concerns related to (but not limited to) health, safety, diversity, social justice, and sustainability; **AND**

WHEREAS, CSUN sponsorships play a vital role in supporting essential UNLV entities and their operations that positively impact the undergraduate student body; **AND**

WHEREAS, the UNLV Global International Success Programs seeks to acquire one-time sponsorship funding in order to support the financial cost for a student-group trip to the Grand Canyon National Park & Skywalk; **AND**

WHEREAS, the UNLV Global International Success Programs has provided a budget to be included under Addendum B; **AND**

WHEREAS, the CSUN University Initiatives Committee shall review the request on September 25th, 2025

during UI 55-11; **AND**

WHEREAS, UNLV Global International Success Programs, after being seen by the University Initiatives Committee on UI 55-11, shall have been approved for an amount not to exceed \$6,196.16;

THEREFORE, BE IT ENACTED that CSUN shall appropriate an amount not to exceed \$6,196.16 from the CSUN FY2025-2026 “New One-Time Sponsorships” budget in order to provide a one-time sponsorship to the UNLV Global International Success Programs for their Grand Canyon National Park & Skywalk Trip.
