4a. Discussion and Approval of Funding for Creative Arts Journal

Chair Curry requests time for the Discussion and Approval of Senate Bill 55-78 For a funding request of no more than \$7,044.00 submitted by Creative Arts Journal all costs must be encumbered from the CSUN FY26 Student Organization Line. Senate Bill 55-78 may be found in the CSUN Legislation Record. The request may be subject to amendment at the discretion of the committee

The RSO is present to give a presentation. They tell us a little bit about their organization and the effect they have on the undergraduate students of UNLV.

Senator Tuitele takes a point of personal privilege from 5:20-5:26 pm

Chair Curry opens the floor to questioning.

Senator Prieto notes that they have only 35 undergraduate members, making their budget over the maximum by over \$800 Dollars. He also notes that the operating policy says we cannot fund subscriptions.

Senator Brooks echoes Senator Prieto on the budget maximum, but says she is okay with funding the subscription because she believes these are critical to the organization.

Chair Curry says they actually have 55 members in the involvement center. This increase means they are not over the maximum.

Senator Prieto asks what the final line item "processing fees" means. The RSO answers that it is used for tax or unforeseen expenses.

Chair Curry says we cannot fund anything that is not an exact number with a quote, we remove this line item.

Senator Perez-Martinez says she is okay with everything else on the budget and points out a clerical error.

Senator Hubshman moves to amend senate bill 55-78 to read "WHEREAS, the student organization, after being seen by the Ways and Means Committee, has been approved for an amount not to exceed \$6,794.00;

THEREFORE, BE IT ENACTED, CSUN shall appropriate \$6,794.00 onetime to fund the Creative Arts Journal and where all costs are to be encumbered from the CSUN FY 25-26 Student Organization Funding Budget in adherence with the Ways and Means Operating Policy.”

The motion is seconded by Senator Preto

*With a voice vote of 8-0-0, the amendment has been approved. *

Vice Chair Coss notes that the bill is mislabeled on the agenda.

Chair Curry says we cannot fund this currently, due to open meeting law. We will come back to this next meeting once this is addressed. We could not vote on this today.

The committee realizes the budget is actually correct, we did not realize there was a second page of the budget.

Senator Brooks rescinds her motion.

Senator Perez-Martinez notes she is a little worried about line item 21-25. She asks if these are compostable or biodegradable.

The committee notes they were unaware of the one-time use rule.

Senator Brooks notes that line items 21,22 and 23 are recyclable. Senator Brooks also notes she is fine funding these because otherwise it would be a health issue.

Chair Curry calls for a voice vote to approve Senate Bill 55-79.
