*Senator Hubshman asks if we are allowed to help with a store, we are, but if they were selling these things directly we would not be able to fund it.*

*Senator Brooks asks if K-cups are reusable.*

*Chair Curry notes there are reusable K Cups.*

*Senator Perez-Martinez asks to go back to line items 2 and 3, she thinks line item 3 is a subscription.*

*Senator Brooks says she is pretty sure that we have funded website domains in the past.*

*The RSO gives us more information on what these domains are being used for.*

*Chair Curry reminds the RSO that we do not fund websites or subscriptions that have free alternatives. Chair Curry recommends that they apply for a UNLV email.*
