5b. Discussion and Approval of Funding for Delta Sigma Theta Sorority, Inc.

Chair Curry requests time for the Discussion and Approval of Senate Bill 55-75 For a funding request of no more than \$4,752.53 submitted by Delta Sigma Theta Sorority, Inc. all costs must be encumbered from the CSUN FY26 Student Organization Line. Senate Bill 55-75 may be found in the CSUN Legislation Record. The request may be subject to amendment at the discretion of the committee

Representatives from Delta Sigma Theta Sorority are present to explain who they are, what they do, and how they affect the undergraduate student body.

Vice Chair Coss raises concern over line items 12, 13, and 14 due to the operating policy. Line item 12 should be halved (it is a conference) and line items 13 and 14 cannot coexist due both being wearable items for general members.

Chair Curry notes that without a quote for line item 12, we cannot fund it.

Chair Curry invites a motion to table while the RSO searches for relevant information

Senator Prieto moves to table the item for 10 minutes.

Senator Hubshman seconds the motion

Chair Curry calls for a voice vote to table the item, with a vote of 6-0-0, item 5b is tabled for 10 minutes.

Tabled at 5:30

Reopened at 5:41 pm

Chair Curry opens the discussion about the Conference Registration (line item 12) and he halves the price. The RSO also removes line item 13.

Senator Brooks clarifies that the conference registration is 560 dollars per person, not for 5 people in total.

Senator Hubshman brings up the idea that it might be out of the fiscal year's cycle, but the funding will go towards the conference in 2026, not July 2025.

Senator Prieto notes that they are about \$700 over budget for only having ten members.

The RSO says they can cut the registration from 5 members to 3 members.

They are still 300 dollars over budget.

Senator Perez-Martinez mentions that there are no names on the senate bill, this is a clerical error and will be fixed after the meeting.

Senator Brooks notes that line item 7 “supplies” must be broken down into separate compartments and should not be grouped together.

The RSO decided to remove supplies entirely.

AG Rejas asks if printing materials can be cut.

Chair Curry notes that this is a service and can stay.

The RSO does not want to reduce their budget, and Chair Curry notes that we will have to cut it down on our own if they do not choose what they want to cut.

The RSO decided to reduce the storage bin by 1.

Chair Brooks asks if we can “print materials” from 10 to 9.

The RSO says we can just remove printing materials and asks for her storage bins back.

This brings their budget down to just over 3,100.

AG Rejas notes that they are under budget and asks if there is anything they want to re-add

Chair Curry gives them a 1 minute time limit to discuss before we vote on the bill.

The RSO asks for a banner that they do not have a quote for.

Chair Curry notes that they cannot do this. He asks if they want printing materials back.

He gives them 8 printing materials back, which brings there budget to just under 4,000.

Senator Brooks moves to amend senate bill 55-75 addendum B to contain the correct budget sheet.

Chair curry notes it already has the correct budget.

Senator Brooks rescinds her motion

Senator Brooks moves to amend senate bill 55-75 to read “WHEREAS, the student organization, after being seen by the Ways and Means Committee, has been approved for an amount not to exceed \$3,967.52;

THEREFORE, BE IT ENACTED, CSUN shall appropriate \$3,967.52 onetime to fund the Delta Sigma Theta Sorority, Inc. and where all costs are to be encumbered from the CSUN FY 25-26 Student Organization Funding Budget in adherence with the Ways and Means Operating Policy.”

The motion is seconded by Senator Prieto

Chair Curry calls for a voice vote, but senator Hubshman notes that it is actually one cent off.

Senator Prieto rescinds his second
