#### AN ACT TO AMEND SENATE BILL 55-147

Bill Number: SB 56-09

**WHEREAS**, the Consolidated Students of the University of Nevada Las Vegas (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; and

**WHEREAS**, the Senate of the Consolidated Students of the University of Nevada Las Vegas, under the authority of CSUN Constitution VI..D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

**WHEREAS**, CSUN must actively advocate for the needs of undergraduate student organizations; **AND**

**WHEREAS**, the student organization has completed all of the necessary documentation as required by the Ways and Means Committee and the Ways and Means Operating Policy; **AND**

**WHEREAS**, the UNLV Harvard Latina Empowerment and Development Chapter provided a Reallocation budget under Addendum A; **AND**

**WHEREAS**, the CSUN Ways and Means Committee will review the request on 2/3/26 during WM 56-02; **AND**

**WHEREAS**, the CSUN Ways and Means Committee allocated funds previously for the UNLV LEAD on 9/30/25 for Ways and Means 55-20 in Senate Bill 147 Under Addendum A; **AND**

**WHEREAS**, the student organization, after being seen by the Ways and Means Committee, has been approved for an amount not to exceed \$8,364.50; **AND**

**THEREFORE, BE IT ENACTED**, CSUN shall amend Senate Bill 147, as outlined in Addendum A, to authorize UNLV LEAD to reallocate funds in adherence with the Ways and Means Operating Policy for CSUN FY25
