---

#### AN ACT TO AMEND SENATE BILL 55-44

Bill Number: SB 56-06

---

**WHEREAS**, the Consolidated Students of the University of Nevada Las Vegas (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; and

**WHEREAS**, the Senate of the Consolidated Students of the University of Nevada Las Vegas, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

**WHEREAS**, CSUN must actively advocate for the needs of undergraduate student organizations; **AND**

**WHEREAS**, the student organization has completed all of the necessary documentation as required by the Ways and Means Committee and the Ways and Means Operating Policy; **AND**

**WHEREAS**, the UNLV Formula Racing provided a Reallocation budget under Addendum A; **AND**

**WHEREAS**, the CSUN Ways and Means Committee will review the request on February 3rd, 2026 during WM 56-02; **AND**

**WHEREAS**, the CSUN Ways and Means Committee allocated funds previously for the Formula Racing on August 26, 2025 for Ways and Means Meeting 55-14 in Senate Bill 55-44 Under Addendum A; **AND**

**WHEREAS**, the student organization, after being seen by the Ways and Means Committee, has been approved for an amount not to exceed \$12,500.35; **AND**

**THEREFORE, BE IT ENACTED**, CSUN shall amend Senate Bill 55-44 as outlined in Addendum A, to authorize UNLV Formula Racing to reallocate funds in adherence with the Ways and Means Operating Policy for CSUN FY25
