SENATE BILL 56-05

AN ACT TO AMEND THE CSUN BYLAW CHAPTER 402

WHEREAS, the Consolidated Students of the University of Nevada Las Vegas (CSUN) represents all 27,000+ undergraduate students enrolled at the University of Nevada Las Vegas; and

WHEREAS, the Senate of the Consolidated Students of the University of Nevada Las Vegas, under the authority of CSUN Constitution VI..D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

WHEREAS, Chapter 402 of the CSUN Bylaws establishes the structure and management of the Annual Operating Budget, including the creation and maintenance of designated financial accounts; **AND**

WHEREAS, the bylaws currently list multiple individual scholarship accounts; however, these program (PG) accounts are subject to change and are administratively managed by University departments and the CSUN Business Operations Coordinator, who processes scholarship transactions; **AND**

WHEREAS, maintaining individual scholarship accounts within the bylaws creates unnecessary administrative inconsistencies, as the listed accounts may change over time and are not directly managed by CSUN through separate standing accounts; **AND**

THEREFORE, BE IT ENACTED, that Chapter 402, Section 05 of the CSUN Bylaws shall be amended to remove the individual scholarship accounts as outlined in Addendum A.

ADDENDUM A

CHAPTER 402: ANNUAL OPERATING BUDGET

SECTION 05: ACCOUNTS

A. Annual Operating Budget accounts shall be created and maintained within this section, and at the direction of the Senate, to segregate revenues and expenditures among the various branches, departments, programs, and services of CSUN.
