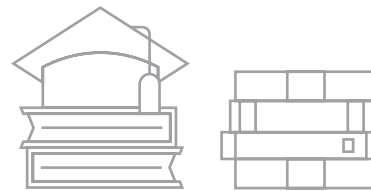

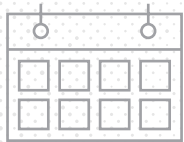

# ADMISSIONS REQUIREMENTS

- Four-year bachelor's degree from a regionally accredited institution **OR** an approved equivalent **AND**
- Minimum overall grade point average of 2.75 for the bachelor's degree **OR** minimum 3.0 GPA for the last 60 credits

In addition to the minimum graduate admissions requirements, each program or academic department may set its own criteria. Program-specific requirements are listed in the Degrees Directory.

# APPLICATION CHECKLIST

## □ **Complete the Application and Pay Application Fee**

Nevada residents, current UNLV students, and non-degree seeking students should apply through the **Grad Rebel Gateway**. Out-of-state and international students should apply through the **Centralized Application Service**. Application fees are \$60 for domestic applicants and \$95 for international applicants. ## □ **Submit Transcripts**

You must submit transcripts from all colleges and universities you have attended. You may upload unofficial transcripts into your online application, but official transcripts will be required after admission.

Students may send unofficial transcripts, and institutions may send official transcripts to [gradadmissions@unlv.edu](mailto:gradadmissions@unlv.edu).

## □ **Determine Whether You Need Additional Application Materials**

Graduate programs may require materials beyond the minimum graduate admissions requirements, such as recommendation letters, essays, or test scores. Review your program's requirements at [unlv.today/graduate-requirements](https://unlv.today/graduate-requirements).

## □ **Submit Proof of English Proficiency (International Students Only)**

Proof of English proficiency is required if you are from a country where English is not the native language or if you did not receive a degree from an institution where English is the primary language of instruction. Official test scores must be sent directly from the testing agency to the Office of Admissions. ## □ **Check Application Status**

## GRADUATE ADMISSIONS REVIEW PROCESS

### **Step 1: Graduate Admissions Review**

Once the application, all transcripts, and proof of English proficiency (if required) are received, the Office of Admissions evaluates these materials to confirm the applicant meets the minimum admission requirements.

### **Step 2: Department Review**

The academic department's faculty or admissions committee then reviews the application to assess qualifications and overall competitiveness. Based on this evaluation, the committee provides an admission recommendation to the Office of Admissions, which issues the final decision.

Applicants are notified of their admission decision by email. A formal decision letter will also be available in their **Grad Rebel Gateway** account at [rebelgateway.unlv.edu](https://rebelgateway.unlv.edu).
