Welcome

The UNLV School of Architecture houses Nevada's only professional architecture program. The Graduate Architecture Program sits within a collaboratively-minded school that offers accredited degrees in Interior Architecture and Landscape Architecture, in addition to Architecture. Under the guidance of our world-class faculty, we have an award-winning design build studio, shops and labs with state of the art digital and fabrication tools, and a Downtown Design Center that utilizes Las Vegas as an urban design laboratory.

Our graduate degree in architecture is supported by 7 theme-based research labs in the School of Architecture and offers five areas of excellence: Hospitality and Entertainment Design, Landscape Urbanism + Community-Based Projects, Sustainable Design, Design-Build, and Campus Planning. We are adding a sixth area of excellence—study-abroad Global Design Studios—in the future, with a pilot study-abroad studio in Mexico City scheduled for Summer 2019.

Message from the Graduate Coordinator:

At times, the diversity of the built environment of Las Vegas seems to be rivaled only by the diversity of our student body. Students come from all over the world to engage one of the most exciting environments as a means of exploring critical issues in architecture today. Situated in UNLV's College of Fine Arts, there are opportunities for collaborative study with students and faculty focused on the performing and visual arts, as well as hospitality, education, engineering, and medicine, among others.

Over the years, Las Vegas and UNLV have played host to architects drawn to this valley for a number of reasons. The Klai Juba Wald Lecture Series has brought such notable architects as Gregg Pasquarelli, Nader Tehrani, James Wines, Greg Lynn, and Glenn Murcutt to speak at the School.

Rem Koolhaas, Zaha Hadid, Daniel Libeskind, Frank Gehry, and Antoine Predock among others have built projects throughout the valley, and site visits to several of these places constitute integral parts of the educational experience. An exceptionally talented local design community has contributed significantly to the cultural landscape of Nevada and, impressively, to the architectural aesthetics in other destinations around the world. No matter your interest, the concentrations and electives offered through the curriculum enable exceptional investigations in our often-extreme context. We look forward to exploring those pressing issues with you, conducting research, and fostering advanced design studies.

Advisory Committee Guidelines

For programs that require a thesis or dissertation, a graduate advisory committee is mandatory and must conform to the Degree Progression Policies and Procedures provided in the [graduate catalog](#). As an alternative to pursuing a written thesis, M. Arch candidates may present a professional project as their culminating experience in a Professional Project Design Course. The Professional Project should address a significant architectural design problem and demonstrate a comprehensive design solution. The instructor of the course determines the requirements and evaluation of this project. The student is required to present his/her Professional Project to a School of Architecture Graduate Committee. These committees are informally assembled in consultation with the students of each respective design concentration for the purpose of providing constructive criticism throughout the design process.

It is the responsibility of the Advisory Committee and the student to meet at least once a year to determine whether or not he/she may advance to the next graduate year. Professional projects and theses must be presented to a committee as outlined in the [graduate catalog](#).

Degree Program Benchmarks

A comprehensive design studio takes place in the AAE771-772 sequence. Through this studio (and its co-requisite ABS 741), students are required to demonstrate a number of NAAB-criteria as described by course syllabi. Successful completion of the comprehensive studio sequence serves as qualifying for study in the concentration areas of the M. Arch. Grading scales, procedures, and other course policies are written in course syllabi and follow guidelines issued by the Office of the Executive Vice President and Provost.

Thesis work follows regulations prescribed by the Graduate College. Culminating Experience projects follow guidelines unique to their concentration areas.

Program Timeline

For students holding a B.S. Arch or B.A. Arch degree, the M. Arch program is a two-year (four semester) full-time program. For students holding a bachelor's degree in something other than architecture, the M. Arch program typically takes three to four years of full-time semesters to

complete based on analysis of past experience. Students entering with a five-year B. Arch degree may be granted advanced standing in the two-year program.

Annual Review Procedures

Each winter break and early spring term, graduate students are **required** to complete the Graduate Student Individual Development Plan (IDP) form. The review covers the prior calendar year and assesses student progress, and it establishes reasonable goals for the year ahead. Reported student data is shared with students' graduate coordinators and advisors to foster opportunities for discussion about students' strengths and weaknesses, accomplishments and next requirements, and mentoring plans so that students know what they need to do in order to progress successfully through their programs in a timely manner. Students who are graduating are also required to complete the form in order to record their achievements since the data is also used to track metrics related to the annual productivity of all students. This survey will be sent by the Graduate College to the student's Rebelmail account. The review covers the prior calendar year and assesses student progress while setting goals for the year ahead.

Probation

If a student fails to successfully progress in their degree program, their department/school will recommend that the student be placed on probation by the Graduate College. Students on probation may be dismissed/separated from their program for failing to successfully meet the conditions of their probation by the deadline provided. Additional Program Information

Clinical internships make up an important component of the path toward licensure as an architect, and the M. Arch program requires students establish a record with NCARB for the Architecture Experience Program (AXP). Minimum thresholds of professional experience are required in the zero- credit internship course, AAD600, and more internship hours are available surrounding students' academic careers. Consult with the School's Architect Licensing Advisor for more information.

Discipline Resources

Writing styles differ between parts of the curriculum. Instructors of classes provide style guides. The architectural industry has several professional organizations, and the School of Architecture is home to student chapters of such organizations as the American Institute of Architects among others.

Conferences include but are not limited to the ACSA Annual Meeting, The ARCC Conference, NIBS Annual Conference and Expo, and NCBDS. The Architecture Studies Library (located within the School of Architecture) maintains electronic and hard copy access to thousands of important architecture and design journals. Additional resources can be found in the studios, computer labs, workshops, NEAT Lab, David G. Howryla Design-Build Studio, and other classroom spaces of the School.

Our SoA (School of Architecture) graduate faculty and Master of Architecture students organize our innovative research and creative activities into seven theme-based labs which define our priority research concentrations. These are the key areas of our research excellence, with groups and networks supporting the Labs:

Aging + Healthcare Design Lab; Theme: City Well-being

This is a joint lab, coordinated by Dr. Dak Kopec in the SoA, and partnered with UNLV's School of Allied Health Sciences, School of Community Health Sciences, The College of Education, and the College of Medicine.

Natural Energies Advanced Technologies (NEAT) Lab; Theme: City Analytics

Coordinated by Alfredo Fernandez-Gonzalez.

atLAS Lab of Advanced Design Technologies; Theme: City Visualization

This is a joint lab, coordinated by Joshua Vermillion, and partnered with the Department of Art, the Department of Anthropology, and The Greenspun College of Urban Affairs.

Urban Futures Lab; Theme: City Futures

This is a joint lab, coordinated by Dr. Steffen Lehmann, and partnered with the College of Engineering and the College of Urban Affairs.

Design + Build Lab; Theme: City Making

Coordinated by Eric Weber with multiple industry partners.

Hospitality Design Lab; Theme: City Activation

Joint lab, coordinated by Glenn Nowak, and partnered with the College of Hospitality, the International Gaming Institute, and the Entertainment Engineering and Design program.

Downtown Design Center (DDC); Theme: City Change

Coordinated by Steven Clarke with multiple community partners.
