AMENDMENT NO. 2 TO CONTRACT 7288 TO PROVIDE ON CALL CHARTER BUS SERVICES FOR THE UNIVERSITY OF NEVADA, LAS VEGAS

THIS AMENDMENT NO. 2 TO CONTRACT 7288 ("Contract"), is made effective December 4, 2017 (the "Effective Date") by and between the Board of Regents of the Nevada System of Higher Education ("NSHE"), on behalf of the University of Nevada, Las Vegas, ("UNLV") and Busco Inc. dba Arrow Stage Lines, a Nebraska Corporation ("Contractor") and is based on the following facts:

RECITALS

On July 6, 2015 UNLV issued its Request for Proposal No. 648-BC (the "RFP") seeking proposals from qualified contractors to provide On Call Charter Bus.

On August 6, 2015 Contractor submitted a proposal ("Proposal") in response to the RFP.

On December 4, 2015 UNLV and Contractor executed the Contract to provide On Call Charter Bus services and as further described in the Contract (collectively, the "Services").

On December 4, 2016 UNLV and Contractor Amendment No. 1 to extend the Contract Term through December 3, 2017.

Based on the foregoing Recitals and for other good and valuable consideration, the parties further agree as follows:

Article 1. Term: The second of four (4) one (1) year renewal options is hereby exercised to extend the Contract Term through December 3, 2018 unless otherwise terminated in accordance with the Contract.

Article 3. Consideration. Exhibit B is hereby deleted in its entirety and replaced with the following Exhibit B 2018.

All other terms and conditions of the Contract shall remain the same.
