In serving as treasurer on the GPSA executive board, I feel that I can bring my organizational skills that I have to aid the Executive Board in the upcoming year. As the entire student body adapts to campus life returning to the on-campus experience, there will be Graduate students that will be transitioning to this experience for the first time that will need the assistance of GPSA in ways that may present new challenges for the board. As a student in this specific position, my experience may help in figuring out situation that may arise. Also, being a transgender individual, I hope that my presence on the executive board of GPSA shows other transgender students that they are represented and seen on this campus and not invisible.

Please list any relevant experience/qualifications for the position: (GPSA experience, student government, extracurricular activities, or other interests)

During my academic career, I have been a part of several organizations that have afforded me the privilege to aid in enacting change. During my Undergraduate career, I participated in the V-Day campaign presented by the University of Louisiana at Lafayette. I was a student at South Louisiana Community College, which is affiliated with UL Lafayette. This campaign raised funds for local battered women's shelters in the Lafayette area and raised awareness on the issue of violence against women through fundraisers and performances of Eve Ensler's play, "The Vagina Monologues". I was a part of this project for two years, the first year as a cast member, and the second year as Stage manager for the play and as a member of the executive board.

Another project I was honored to participate in during my undergraduate career was the founding of the Delgado Community College student pantry. I networked with the Trio student services organization to establish, organize, and physically set up the pantry, and aid in the weekly disbursement of food to students in need. This was an experience that touched me in many ways. Seeing how I could aid my fellow students in New Orleans humbled me.

During my master's program, I was given the opportunity to teach an undergraduate course as the campus transitioned from in-person classes to remote learning. This opportunity tested my ability to manage almost 100 undergraduate students academically as they transitioned to complete online studies while managing my own studies (which included the writing of my master's thesis.) I learned the imperative skills of time management, work/life balance, and self-care that are necessary to handle multiple responsibilities.

Finally, I have over five years of mental health work experience that afforded me insight and understanding of all different populations of individuals. I cannot describe in words how this experience has shaped me. It allowed me to learn how to work within a team environment in high stress situations that could change at any moment. I worked at this job while completing my undergraduate degree and master's program as a full-time employee, full time student, and at one point commuting two hours daily to fulfill all of these commitments.

POSITION DESCRIPTIONS:

President

President is the chairperson of the GPSA Council and Executive Board. This position is responsible for guiding the organization on general issues such as goals of the Council. The President also represents the GPSA at the Board of Regents meetings and travels to other locations when the meetings are held outside Las Vegas (travel expenses paid by GPSA).

The President serves on the Graduate Council, the Executive Council, as well as on several campus-wide committees. The President speaks at various student orientations and campus engagements. Due to impromptu requests (speaking, serving on committees, etc.) from different entities on campus throughout the year, it is highly recommended that candidates for this position have a flexible schedule.

This position offers a graduate student tuition waiver of up to 9 credits a semester, a monthly stipend equal to that of a graduate assistant, a Graduate College Leadership Scholarship (academic year breakdown: Summer - \$5,000; Fall - \$2,000; Spring - \$2,000) and a GPSA \$550 stipend for each semester (Summer, Fall, Spring; paid monthly from May to April).

Candidates must be in good academic standing, admitted to a graduate and/or professional program at UNLV, and must have previous experience on the GPSA Council as a representative or as a previous executive board member

Vice President

The VP chairs the Sponsorship Committee which evaluates applications and distributes GPSA funding allocations for students' research and conference travel and serves on several campus-wide committees. The Vice President establishes priorities for the sponsorship funding in conjunction with the Committee and Executive Board. This position also conducts Sponsorship Funding Workshops in order to assist students on how to successfully apply for GPSA Sponsorship funding.

The Vice President also chairs the GPSA Annual Student Research Forum held in the spring semester. The Vice President attends the Board of Regents meeting in the President's absence and acts as President if the office becomes vacant. The Vice President also sits on a Graduate College Committee and other campuswide committees.

This position offers a Graduate College Leadership Scholarship (academic year breakdown: Summer - \$3,000; Fall - \$2,000; Spring - \$2,000) and a GPSA \$550 stipend for each semester (Summer, Fall, Spring; paid monthly from May to April).

In the absence of the President, the Vice President shall chair the Council.

Candidates must be in good academic standing, be admitted to a graduate and/or professional program at UNLV and must have previous experience on the GPSA Council.

Treasurer

The Treasurer presents a financial report at every monthly GPSA Council meeting. This position chairs the Government Relations Committee, Awards Committee, and serves on several campus-wide committees. The Treasurer also sits on a Graduate College Committee. During a legislative year, it is expected that the Treasurer travel to Carson City one or two times to meet with the governor, state legislators, etc.

This position offers a Graduate College Leadership Scholarship (academic year breakdown: Summer - \$3,000; Fall - \$1,000; Spring - \$1,000) and a GPSA \$350 stipend for each semester (Summer, Fall, Spring; paid monthly from May to April).

The Treasurer will fill the Vice President's office in the event of its vacancy.

Secretary

This position also chairs the Publication Committee, sits on a Graduate College Committee and several campus-wide committees.
