
- 1. General Announcements/Updates
  - a. CoRE Fellows Update Jennifer Keene
    - i. CoRE Fellows are having monthly teleconferences over the summer
    - ii. Currently planning events for Fall 2014

    - i. Currently in negotiations with Director candidate
- 2. Research Faculty Fellow FY2014-FY2015
  - a. A part/full-time position will be posted in the Division of Research for a Faculty Fellow for FY2014-FY2015

- 3. Research Integrity Updates (AAALAC, "A" License, and IRBNet) Lori Olafson
  - a. AAALAC
    - UNLV was last awarded full accreditation by the Association for Assessment and Accreditation of Laboratory Animal Care (AAALAC) in November 2011
    - ii. An institution must be re-evaluated every three years in order to maintain accreditation status. The accreditation process includes submission of a detailed program description and a site visit. UNLV's program description was provided to AAALAC on April 1, 2014 and the site visit occurred on June 20, 2014.
    - iii. The site visitors did not identify any serious deviations that must be corrected to continue full accreditation. However, six *Suggestions for Improvement* (SFIs) were noted.
    - iv. A corrective action plan for each SFI has been proposed to AAALAC
    - v. We anticipate receiving full accreditation in Fall 2014
  - b. "A" License
    - i. Radioactive Material License was upgraded on June 19, 2014 from a Type B broadscope License to a Type A Broadscope License
    - ii. Most universities with moderate to large radioactive material programs hold Type A licenses
    - iii. The former Radiation Safety Advisory Committee (RSAC) has become a Radiation Safety Committee with specific responsibilities defined in a set

of bylaws and supported by the VPRED's office. This committee is chaired by Ralf Sudowe.


#### c. IRBNet


- i. CyberIRB has been the electronic submission system for human subjects protocols since 2008
- ii. Given the functionality issues with CyberIRB, this system was never implemented campus-wide. Currently, approximately 56% protocols are submitted using CyberIRB while the remaining 44% are submitted via email.
- iii. Moving to a new system (IRBNet) will allow transition to a single paperless system that supports IRB, IACUC and IBC and provides upgrades to the users (PIs) and administrators.
- iv. Transition to the IRBNet will begin in Fall 2014.


#### Amount and Number of Awards by Agency for FY08-13







#### Office of Technology Transfer Data for FY2008-2013










