Short-Term Rental Agreement Procedure

Last Updated: June 10, 2025

Step 1: Initiate

Requester reaches out to PCard/Buyer for guidance or refer to the Purchasing webpage for the short-term rental agreement attachment: https://www.unlv.ed u/purchasing/forms

Step 2: Execute Department completes the Agreement with:

- HomeownerName
- Property Address
- Dates/Length of stay
- # of guests staying
- Homeowner's Signature

Step 3: Circulate

Buyer circulates Agreement for signature in DocuSign

- Recommending official (Dean or above)
- Initialed by Assistant Director
- Signed by Executive Director

Step 4: Pay

PCard: A fully executed copy of the Agreement is sent to PCard email. PCard sends approval to Requester with Agreement. PCard requests reservation summary screenshots.

PO: Buyer attaches Agreement to PO in Workday.

Step 5: Save

Buyer saves Agreement to Shared Drive: 'Short-Term Rental Agreements Folder'
