SENATE BILL 55-38

AN ACT TO AMEND THE CSUN BYLAW CHAPTER 1201

WHEREAS, the Consolidated Students of the University of Nevada (CSUN) represents all 25,000+ undergraduate students enrolled at the University of Nevada Las Vegas; **AND**

WHEREAS, the Senate of the Consolidated Students of the University of Nevada Las Vegas, under the authority of CSUN Constitution VI.D.01, is “empowered to enact any legislation that falls under the jurisdiction of CSUN”; **AND**

WHEREAS, under Chapter 1200 of Title XII of the CSUN Bylaws, the CSUN Sponsorship Fund is established to provide recurring annual financial support to UNLV entities; **AND**

WHEREAS, Section 09 under Chapter 1200 of Title XII of the CSUN Bylaws establishes the ability to “alter the conditions, provisions, and agreements of a current sponsorship, without discontinuation”; **AND**

WHEREAS, the University Initiatives committee (under the Legislative Branch of CSUN) serves with the purposes of improving the UNLV campus and community, addressing and advocating for undergraduate student interests, needs, and concerns related to (but not limited to) health, safety, diversity, social justice, and sustainability; **AND**

WHEREAS, CSUN sponsorships play a vital role in supporting essential UNLV entities and their operations that positively impact the undergraduate student body; **AND**

WHEREAS, Chapter 1201 of Title XII of the CSUN Bylaws establishes the UNLV/CSUN Preschool Sponsorship, which provides a permanent funding mechanism that provides a discounted rate to undergraduate students for enrollment in the Preschool; **AND**

WHEREAS, the CSUN University Initiatives Committee shall review the request for increased sponsorship funding on August 11th, 2025 during UI 55-10; **AND**

WHEREAS, the UNLV/CSUN Preschool, after being seen by the University Initiatives Committee on UI 55-10, shall have been approved for an increase of funding of an amount not to exceed \$25,000.00;

THEREFORE, BE IT ENACTED that the following amendments to the CSUN Bylaw Chapter 1201 be adopted to reflect the changes outlined in Addendums B, C, and D; **AND**

BE IT FURTHER ENACTED, that the amendments proposed to the CSUN Bylaw Chapter 1201 aim to: 1.) aid in increasing the total enrollment amount for undergraduate students by providing increased financial support (reflected in Addendum C), and 2.) provide more specific and concise information regarding the sponsorship through its wording and contents; **AND**

BE IT FURTHER ENACTED, CSUN shall appropriate an amount not to exceed \$25,000.00 from the CSUN FY2025-2026 “New/Existing Sponsorships” budget in order to increase the funding amount allocated to the UNLV/CSUN Preschool Sponsorship.

CHAPTER 1201: UNLV/CSUN PRESCHOOL SPONSORSHIP

SECTION 01: PURPOSE

- A. ~~To create a permanent funding mechanism for the UNLV/CSUN Preschool, founded by CSUN and UNLV in 1974.~~ *To provide a permanent funding mechanism for the UNLV/CSUN Preschool, which was founded by UNLV and in partnership with CSUN in 1974.*
- B. *Allocated funds shall be utilized to provide a discounted rate to undergraduate students for enrollment in the UNLV/CSUN Preschool.*

SECTION 02: FUNDING

- A. ~~Each September, an amount of twenty-five thousand dollars (\$25,000) from the CSUN Sponsorship Budget received from student fees shall be transferred to the UNLV/CSUN Preschool from the CSUN sponsorship budget.~~ *Once per fiscal year, an amount of fifty thousand dollars (\$50,000) from the CSUN Sponsorship Budget shall be transferred to the UNLV/CSUN Preschool to provide a discounted rate to undergraduate students for*

enrollment in the UNLV/CSUN Preschool.

SECTION 03: REQUIREMENTS

- A. ~~Each August the UNLV/CSUN Preschool shall submit to the Internal Affairs Committee a budget that meets these requirements and justifies the continued sponsorship of the UNLV/CSUN Preschool. Once approved by the Internal Affairs Committee, an amount not to exceed \$25,000 will be transferred to the UNLV/CSUN Preschool from the CSUN sponsorship budget.~~ *Once per fiscal year, a representative from the UNLV/CSUN Preschool shall provide a report to the CSUN University Initiatives committee containing (but not limited to) the following information: active fiscal year spending report, upcoming fiscal year budget, relevant statistics and data, accomplishments, operations and activities, etc.*
- B. ~~The UNLV/CSUN Preschool shall use this sponsorship to continue to offer a discounted rate to UNLV undergraduate students, not to exceed 80% of the general public rate. The discounted rate provided to undergraduate students shall not exceed eighty-percent (80%) of the current general public rate. Undergraduate child enrollment shall be no less than 20% of the total previous academic year. Undergraduate child enrollment shall be no less than 18% of the total preschool enrollment for both the fall and spring semesters, as determined thirty (30) days after the start of each semester.~~
- C. *Undergraduate student enrollment shall be no less than twenty-percent (20%) of the total enrollment from the previous academic year.*
- D. *Undergraduate student enrollment shall be no less than eighteen-percent (18%) of the total enrollment for both the fall and spring semester.*
 - 1. *Enrollment information shall be determined thirty (30) days after the start of both the fall and spring semester.*
- C. ~~Representatives from the UNLV/CSUN Preschool shall provide various reports to CSUN:~~
 - 1. ~~Give a report on the preschool's use of the sponsorship budget.~~
 - 2. ~~Give a report on the percentage of undergraduate children enrolled in the preschool once in the fall semester, and once in the spring semester.~~
- E. ~~CSUN's name shall be featured prominently on preschool sponsored marketing material as well as continue to be featured prominently in the name of the preschool.~~ *CSUN's name and/or official logo shall be featured prominently on all presentations and marketing materials.*
 - 1. ~~Either an official CSUN logo or the words "UNLV-CSUN" shall appear on team-sponsored marketing materials prepared by the UNLV/CSUN Preschool or CSUN.~~
 - 2. ~~For purposes of this section, marketing materials shall be defined as shirts, flyers, or any other materials designed to promote.~~
 - 1. *Marketing materials shall be defined as any item(s) designed and utilized to*

promote the UNLV/CSUN Preschool. Examples of marketing materials include (but are not limited to): clothing, bags, stationary, flyers/posters, etc.

F. CSUN's name shall be featured prominently within the name of the preschool.

~~E. It is the responsibility of the current Chair of University Initiatives to contact the UNLV/CSUN Preschool prior to March 31st of each fiscal year to present them with the most recent copy of their sponsorship.~~

~~G. All funds not expended by the UNLV/CSUN Preschool at UNLV for any and all purposes outlined within this chapter shall be returned to the CSUN Sponsorship Budget on or before April 30 of each calendar year.~~
